Thurston County experiences flooding and flood losses in five major river systems, standing water flooding in the prairie areas, marine coastal and lake flooding. We utilize mitigation grants from FEMA, both HMPG and PDM; grants from Ecology, both FCAAP and Floodplains by Design; HUD community block grants; and Cooperating Technical Partners grants in addition to Flood Authority grants. Presently Thurston County is elevating two structures in the Deschutes watershed using a HMP grant. Currently the Flood Authority is the only program accepting proposals.
