WHEREAS, the CONTRACTOR has agreed to install FEMA compliant foundation flood openings at My/Our property for an amount not to exceed \$ 19,762 (plus tax) and the State of Washington has agreed to pay such amount as stated on Form 3 -- State of Washington Approval of Bid.

The parties to this CONTRACT hereby agree to the following terms and conditions as follows:

1. The Owner(s) grants permission to the CONTRACTOR to enter the Property at a prearranged date and time for the sole purpose of installing FEMA compliant foundation flood openings as shown on Form 2 and approved on Form 3 (both attached). The Owner(s) agrees to sign necessary building and permitting applications as may be required to complete this work.
2. The Owner(s) understand the project will require that holes be cut in the foundation of My/Our residential and/or business structure and there may be some unavoidable damage to plantings in close proximity to the foundation work, for which the Owner(s) shall be responsible.
3. The Owner(s) will not be responsible for the costs of installing the foundation flood openings.
4. The CONTRACTOR will seek compensation for the costs of installing the foundation flood openings solely from the State of Washington pursuant to the State of Washington Approval of Bid.



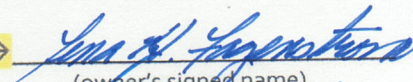

Form 3-2015 -- State of Washington Approval of Bid

1. Subject to the General Terms and Conditions and other provisions of RCO Contract No. 15-1030 and RCO Contract No. 15-1031, as applicable, the State of Washington, acting through the Recreation and Conservation Office (AGENCY), approves Clean Space Northwest's attached bid to install FEMA compliant foundation flood openings in the residential and/or business structure located at:

2. The State shall reimburse Clean Space Northwest up to but not exceeding the amount of \$19,762 + tax, upon satisfaction by the CONTRACTOR of the following:
- CONTRACTOR certifies to the AGENCY it has obtained a FEMA Elevation Certificate (EC) from a Registered Land Surveyor licensed in the State of Washington and provided the same to the building owner with a copy to the local Basin government.
 - Following inspection of the installation by a building code official, CONTRACTOR provides the AGENCY a copy of the building code official's final approval of the installation of FEMA compliant foundation flood openings in the residential and/or business structure identified in the above bid.
 - The CONTRACTOR has provided the AGENCY properly completed invoices that describe and document to the AGENCY'S satisfaction a description of the work performed, final approval of the building code official, and fees. To receive reimbursement, CONTRACTOR must provide a detailed breakdown of authorized expenses, identifying what was expended and when.
3. Payment shall be considered timely if made by the AGENCY within thirty (30) days after receipt of properly completed invoices. Payment shall be sent to the address designated by the CONTRACTOR.

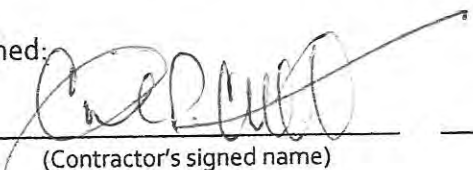

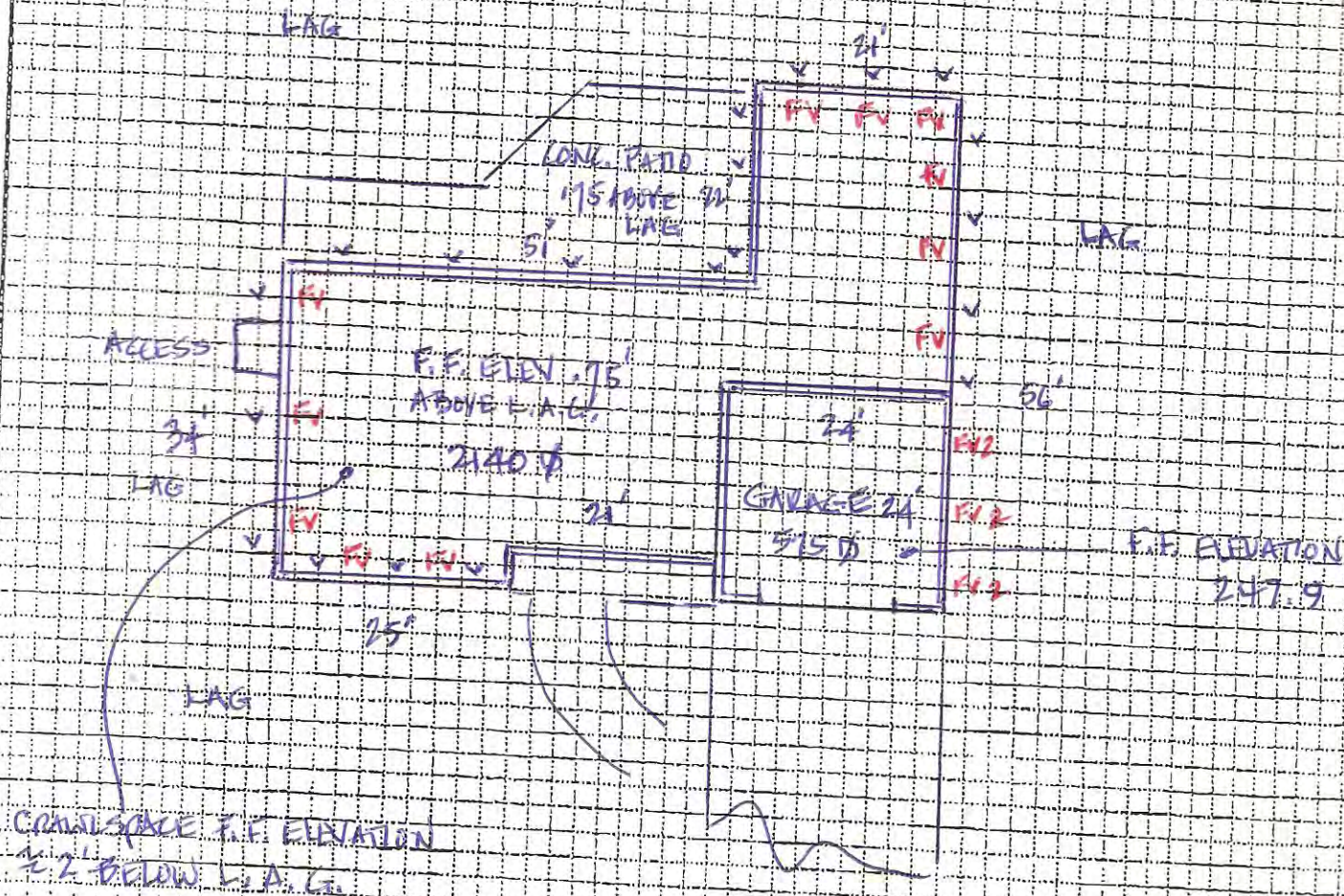

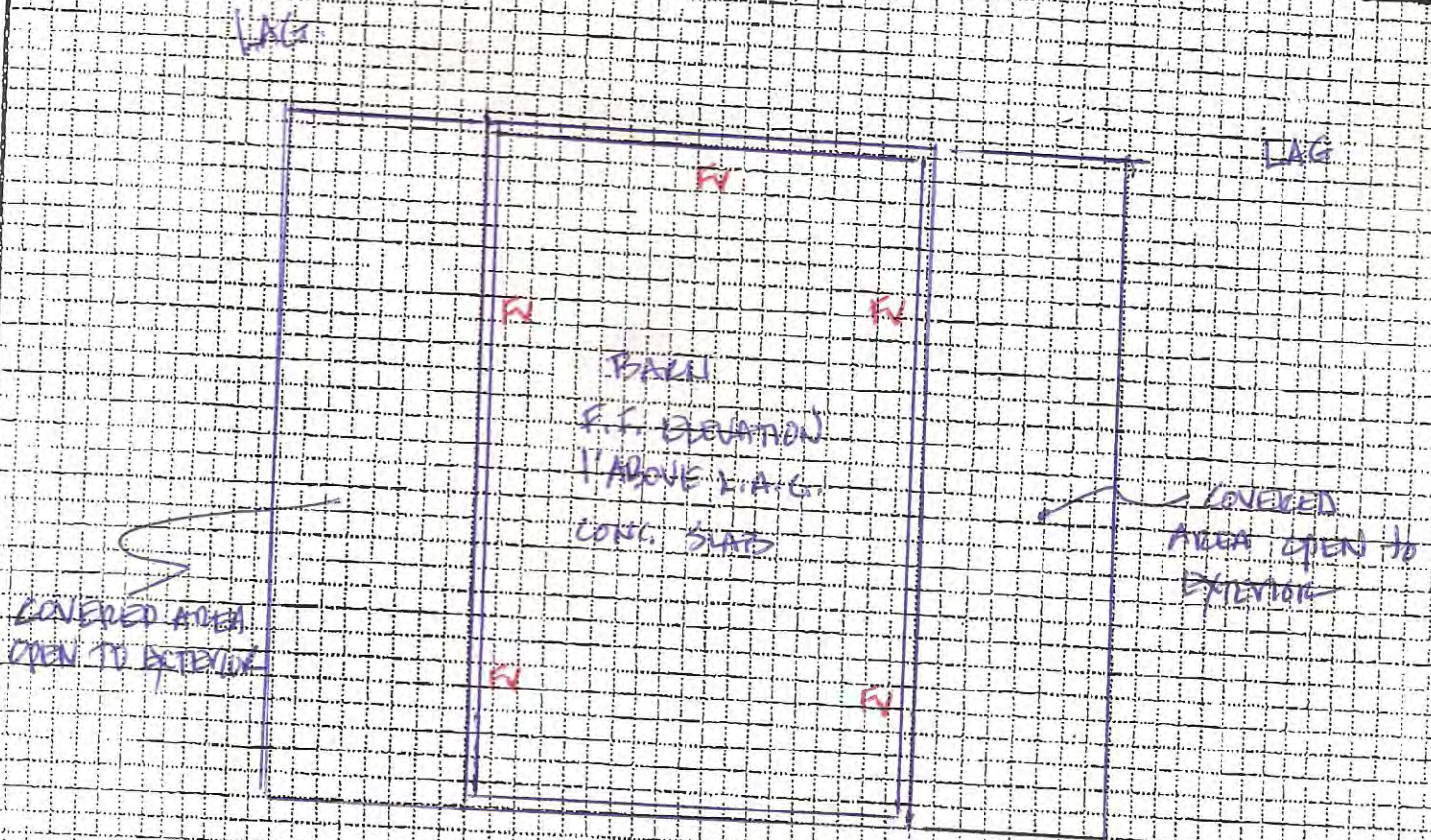
