1. General Description of Proposal:

Adding to UGA:
S20T14R32

The City has received requests from land owners to be annexed into the City limits to be able to construct a race track. Currently the land is located outside of the urban growth boundary and therefore the City is unable to annex the property.

Removing from UGA:
S7T14R32

The City has received a request from the land owner to be removed from the City's UGA since the land is used for farming and will not be used for any other purpose.

2. Why is the UGA or Map Amendment needed and being proposed?

Adding to UGA:
S20T14R32

Without the expansion of the UGA the City is unable to annex the property. The landowners would not be able to develop the land. The City would provide water and sewer services to the property. The land is currently adjacent to the existing UGA.

Removing from UGA:
S7T14R32

The City is proposing to re-designate all land zoned as Agriculture within the city to an "Urban Reserve" designation. For farming purposes, the land owner of the subject property wishes to keep his land zoned "agriculture" and therefore wants to remove his land from the City of Connell's incorporation limits and UGA, and instead be controlled by county zoning code.

3. Describe the land uses surrounding the proposed amendment area (residential, commercial, agriculture, etc):

Adding to UGA S20T14R32

NORTH: It is located in Franklin County and is zoned Ag. Production

SOUTH: It is located in Franklin County and is zoned Ag. Production

EAST: It is located in Franklin County and is zoned Ag. Production

WEST: Is located in the City of Connell and is currently zoned agriculture. The City is in the process of updating zoning designations and will be changing all agriculture land to urban reserve.

Removing from UGA S7T14R32

NORTH: It is located in Franklin County and is zoned Ag. Production

SOUTH: It is located in Franklin County and is zoned Ag. Production

EAST: Is located in the City and is currently zoned agriculture. The City is in the process of updating zoning designations and will be changing all agriculture land to urban reserve. The parcel is owned by the same individual. The owner requested that adjacent land be de-annexed but not removed from the UGA.

WEST: It is located in Franklin County and is zoned Ag. Production

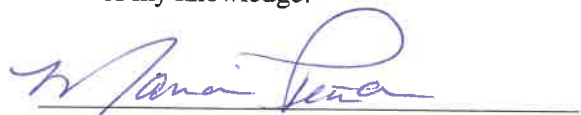

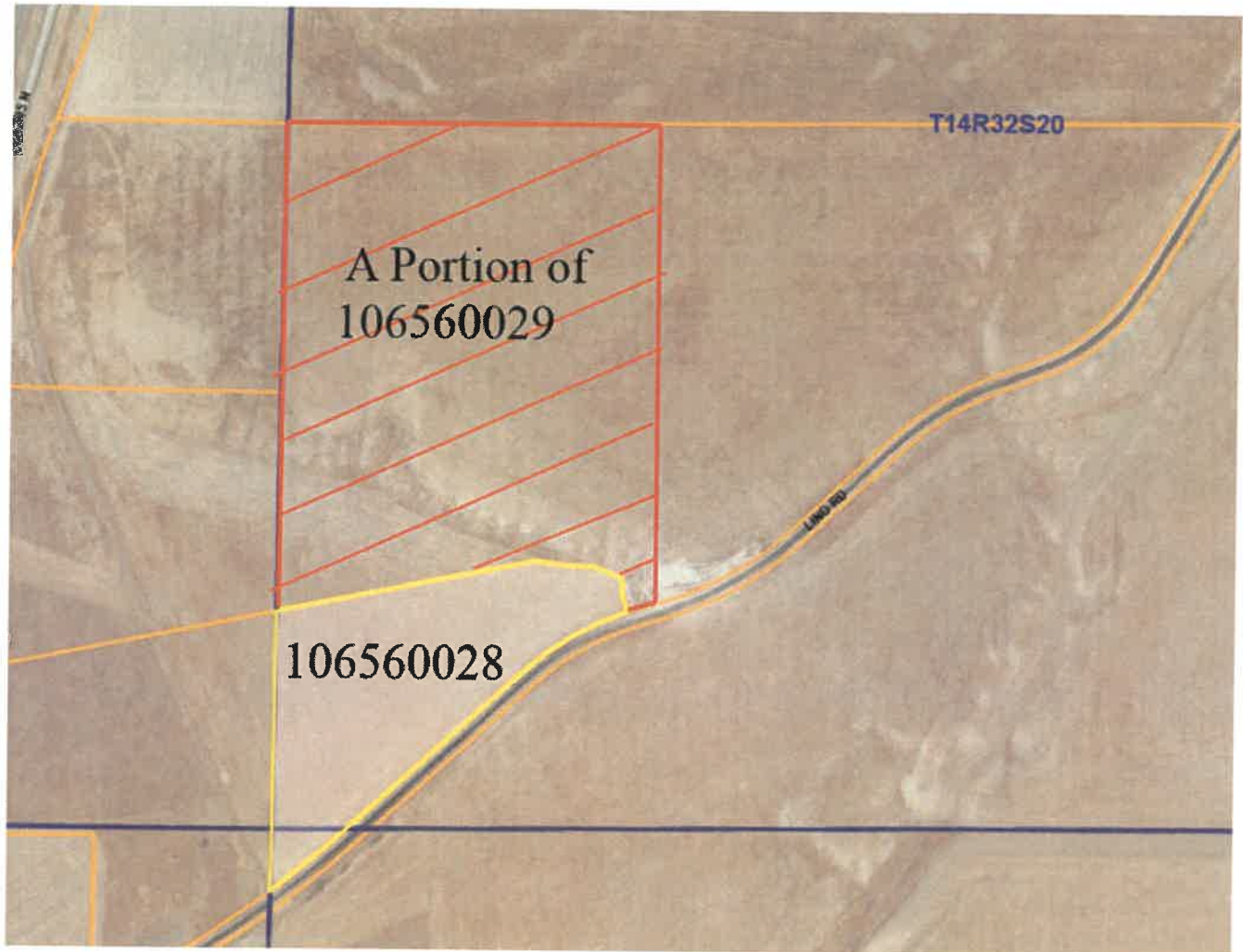

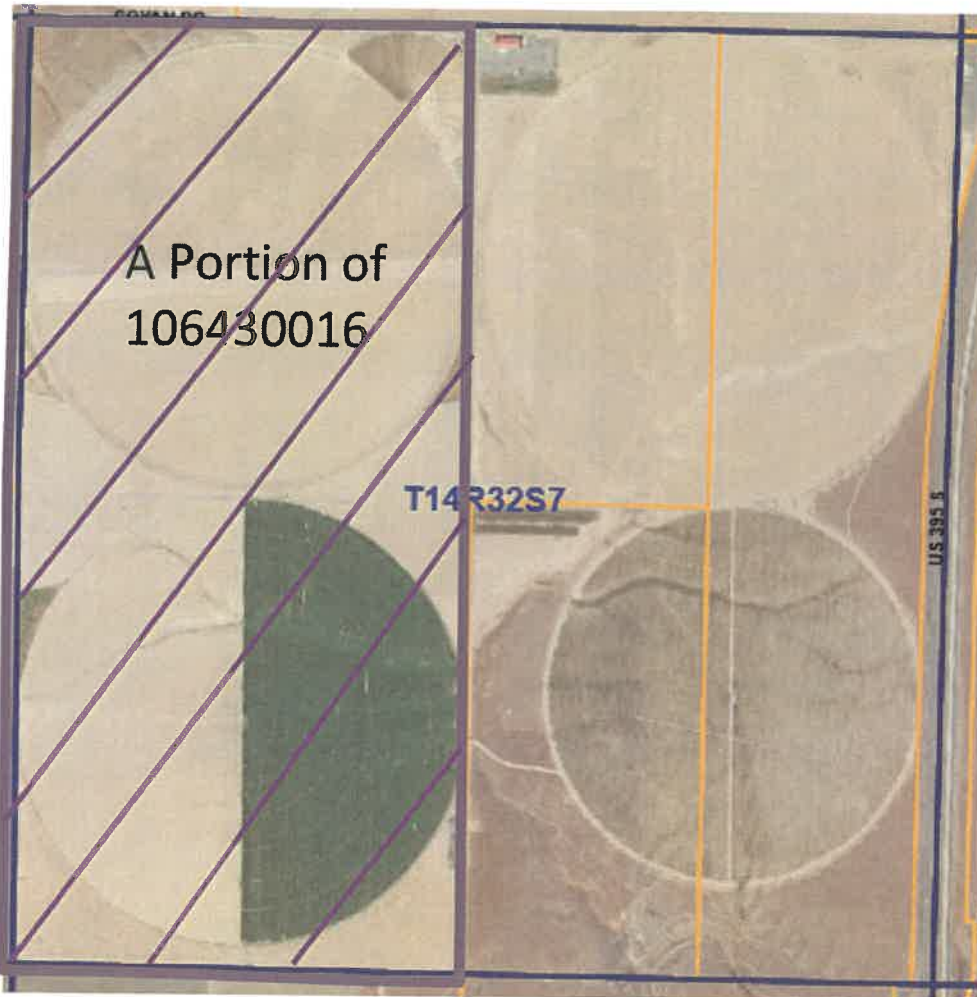
