#### 1. Call to Order

Edna Fund, Vice Chair, called the meeting to order at 10:02 am.

### 2. Introductions & Determination of Quorum

Introductions were made. 8 Flood Authority members were present, there was a quorum.

### 3. Approval of May 18, 2023 Agenda

Ron Averill moved to approve the meeting agenda for May 18, 2023. The agenda was approved.

# 4. Approval of March 16, 2023 Meeting Notes

Ron Averill moved to approve the meeting notes from March 16, 2023. The minutes were approved.

### 5. Refill Expiring Chehalis Basin Board Position

Scott shared that Jay Gordon, one of the Flood Authority's four-year appointments to the Chehalis Basin Board, ends on July 1, 2023. Jay Gordon submitted an application to fill this position for the 2023-2027 period.

Ron Averill made a motion to appoint Jay Gordon as the Chehalis Basin Board Representative. The motion was seconded by Brian Shay. The vote passed unanimously.

### 6. LAND: Overview, Flood Authority Connection

Alex Dupey gave a presentation on the Chehalis Basin LAND (Local Actions Non-Dam Alternative). *See presentation for details*.

Edna shared that CFAR will be at the next Chehalis Basin Board meeting to present.

# 7. Chehalis Basin Strategy: Overview, Flood Authority Connection

Sam Imperati gave a presentation on the Chehalis Basin Strategy. See presentation for details.

### 8. Concurrence with Executive Action

Scott shared recently identified unmet funding needs from the Port of Grays Harbor and Port of Chehalis and the funding approach proposal to meet those needs (*see Executive Committee Decision for details*).

The Projects Committee recommends staff be directed to, as quickly as possible, work with sponsors (Ports), RCO, OCB and CBB to implement the proposed funding approach; and work with Lewis County, RCO, and OCB to carry-forward any surplus funds from Lewis County's 2021-23 Flood Authority Fiscal Agent funding agreement with RCO to its new 2023-25 funding agreement.

Brian Shay moved to approve the projects committee action, seconded by Ron Averill. The motion passed unanimously.

# 9. Current/Upcoming Local Projects

Scott displayed the current and upcoming local projects tables and gave an overview of the new and current projects (*see Local Projects table for details*.)

### **10. Flood Authority Interlocal Agreement**

Scott provided an overview of the current Interlocal Agreement and pointed out the proposed changes.

Scott will make the proposed changes and send the document out today so that jurisdictions can approve the agreement by June 22<sup>nd</sup>.

Scott share that there is an opportunity to explore linkages between the Flood Authority and the Flood Control Zone District. With the Flood Authority's concurrence, Scott would work with Erik Martin and the Flood Authority's Projects Committee to more precisely identify and define linkages, opportunities (administrative, organizational, service delivery, etc.), next steps, etc., and report back at the July 20, 2023 Flood Authority meeting.

The Flood Authority supports the recommendation but expressed some concerns.

### 11. Chehalis Basin Board (Jay Gordon)

Jay Gordon shared that there has been a large focus on the Skookumchuck dam, particularly in the Centralia area. Jay shared his reservations about the project. The Board is having conversations on short term Salmon recovery and hatcheries. The Board is spending too much time and money on habitat.

### 12. Public Comment

There were no members of the public who wished to comment.

# **13. Financial Reports**

Lee Napier from Lewis County Community Development reported that expenditures for March were \$26,342.34 for salaries and wages (Lewis County Staff) and consulting services for SBGH and WEST Consultants. Expenditures for April were \$16,560.66 for the same budget lines.

Ron Averill asked if there will be money leftover and if so, what will be done with those funds. Lee responded that the full amounts for SGBH and WEST consultants will likely be spent in full. The amount for Salaries & Wages will likely not be exhausted since staff are not traveling as much.
