The work to be performed under this contract consists of installing flood protection structures in the Lower Satsop River. Bid items include: Mobilization, Lump Sum; Erosion/Water Pollution Control, Lump Sum; Type 1 Apex ELJ, 7 Each; Type 2 Apex ELJ, 1 Each; Type 1 Deflector ELJ, 9 Each; Type 1 Floodplain Roughness ELJ, 7 Each; Timber Complex Unit ELJ, 4 Each; Type 1 Setback Revetment, 6 Each; Type 2 Setback Revetment ELJ, 12 Each; Excavation of Temporary Relief Channel, 10,000 CY; Racking Logs, 5,114 Each; Slash, 3,475 CY; 36" Dia.
