Recap of 2014-2018 Allocation Approach

Annual costs for 2014, 2015, 2016, 2017, and 2018 were allocated among the three Flood Authority counties as follows:

- Grays Harbor County -- 22%.
- Lewis County -- 64%.
- o Thurston County -- 14%.

The method behind the allocation was as follows:

- 50% of the allocation was based on populations of communities prone to flooding.
- o 50% was based on historic FEMA flood insurance payments.

This allocation approach was unanimously supported by the Flood Authority beginning in 2014 (see <u>here</u>).

Staff Recommendation

Flood Authority agrees to use the same allocation approach as last year (see <u>here</u>) on the basis that relatively not a lot has changed in the Basin in terms of population shifts and/or exposure to flood risk, i.e., Lewis County still has largest population and risk exposure in the Basin.

2019 annual costs are proposed in the same manner as 2018 with Grays Harbor County paying 22% of costs, Lewis County paying 64% of costs, and Thurston County paying 14% of costs. Costs for 2019 are as follows:

Staff will work with Lewis County to prepare payment schedule (1st half due 3/31/2019; 2nd half due 7/31/2019).

Note: Lewis County, acting as fiscal agent for the Flood Authority, has historically handled billing and processing for payments associated with the Flood Warning System. It is assumed this practice will continue for 2019. It should be noted however that Lewis County's role here could be modified/adjusted as further thought and consideration is put into ownership, operation and maintenance of the Flood Warning System in light of the Office of Chehalis Basin and Lewis County Flood Control Zone District assuming more prominent roles in the Basin.
