AUDIT SUMMARY

Results in brief

In the areas we audited, Authority operations complied with applicable requirements and provided adequate safeguarding of public resources. The Authority also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Chehalis River Basin Flood Authority from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- Vendor trend analysis
- Contracts and agreements
- Disbursements

INFORMATION ABOUT THE AUTHORITY

The Chehalis River Basin Flood Control Authority was formed in May 2008 to lead the effort to evaluate flooding issues throughout the Chehalis River Basin and identify and prioritize flood hazard mitigation projects. The Authority consists of officials from jurisdictions in the Basin that are affected by flooding, including Lewis County (lead agency), Thurston County, Grays Harbor County, the Cities of Centralia, Chehalis, Montesano, Aberdeen, Oakville, Napavine and Cosmopolis and the Towns of Pe Ell and Bucoda. An interlocal agreement was adopted by these jurisdictions for the purpose of study, analysis and implementation of flood control projects to protect the Chehalis River Basin. The Authority's budget is established by the Office of Financial Management (OFM) during each State budget biennium. Once the budget is established, OFM reimburses the Authority on a monthly basis for expenditures. For fiscal years 2012 through 2014, the Authority had expenditures of \$637,086, \$193,135 and \$383,513, respectively.

The Authority is governed by a Board comprised of one nonvoting Director appointed ex officio by the state, one voting Director appointed by each Member and one voting Director appointed jointly by the cities within the boundaries of the Authority. An Executive Officer administers the Authority's day-to-day operations.
