.09 Criteria

Purpose

Counties must consult cities, towns, port districts, and associate development organizations in order to disburse funds. As per RCW 82.14.370 the funds may only be used to:

- 1. finance "public facilities" that serve "economic development purposes"
- 2. finance personnel in economic development offices

Public Facilities Definition

As per RCW 82.14.370 public facilities are defined as the following:

- · bridges, roads, railroads, and transportation infrastructure
- · domestic & industrial water facilities, sanitary sewer facilities, and storm sewer facilities
- research, testing, training, and incubation facilities
- · electrical facilities, natural gas facilities, telecommunications infrastructure
- · commercial infrastructure, port facilities, earth stabilization
- buildings, structures

Economic Development Definition

As per RCW 82.14.370 economic development purposes under this law means that the project:

· facilitates the creation or the retention of business and jobs

Economic Development Office Definition

As per RCW 82.14.370 economic development office is defined as:

- office of a county
- associate development organizations (RCW 43.330.010)

Statute Defined Uses

As per RCW 82.14.370 the following are uses as defined in the statute:

- capital facilities costs, including acquisition, construction, rehabilitation, alteration, expansion, or improvements of public facilities;
- costs of development and improvement for the public facilities;
- · project-specific environmental costs;
- · land use and permitting costs;
