**SUBJECT:** Looking Ahead: Chehalis Basin Strategy, Chehalis River Basin Flood Control Zone District

(FCZD), Future Local Projects

## **Background**

Following the July 2023 Flood Authority meeting, work continued looking forward to plan how to ensure the Flood Authority continues to be current, relevant, and have a positive impact on flood preparedness and mitigation in the communities served by Flood Authority members. Forward-looking activities currently span three interconnected efforts: Development of the Chehalis Basin Strategy; Collaboration with the FCZD; and compiling a list of future local projects.

## **Description and Proposed Activities**

- 1. Development of the Chehalis Basin Strategy:
  - See Process and Timeline Slides Extracted from Sept. 7 meeting slides.
  - Next steps Oct 5-6 OCB Meeting/Retreat: develop baseline and tentative "Packages."

How can the Flood Authority engage in the process?

- Engage with Flood Authority appointed CBB members.
   (Related/Existing activity: bi-monthly updates from OCB Board members => more emphasis here)
- ii. OCB will be thinking about the role of the FA in the long-term strategy => provide input/contribute to the vision; present vision/ideas on FA role to the CBB\*\*.
   (Related/Existing activity: FA/FCZD discussions about short and long-term collaboration and synergies)
  - \*\*NOTE: FA "role" has been defined through recent <u>FA Survey</u> and new <u>FA ILA</u>.
- iii. Contribute to Package content **and** the federal funding strategy. OCB staff will need to develop details around the Packages evaluated for the long-term strategy development. OCB also needs well-vetted projects with local partners for federal funding strategy development.

(Related/Existing activity: Development of a list of **Future Local Projects**)

- 2. Collaboration with the FCZD:
  - 2023-2024 Flood season collaboration.
  - More frequent check-ins/updates.

What will this look like?

- i. Joint promotion of the annual Flood Warning System (Stretch goal: 3,000 sign-up people!)
  - a. Include the FCZD in list of partners.
  - b. Communications planning and update on-line materials (also leverage OCB resources and publication of the local project success story)
  - c. Distribute announcements to the FCZD mailing list.
- ii. Brainstorm funding sources for Flood Warning System capital improvements
- iii. November update/presentation from FCZD at the Nov 16, FA meeting
- 3. Compiling a list of future local projects (per agenda item #10):
  - Maintain the list of shovel-ready projects for when new funding is made available.

    E.g., we started the 2021-2023 biennium with ~\$4M in FA local projects, mid-way new funding was made available and that number was increased to ~\$8M in FA local projects!
  - "Real," community supported projects integrated into the long-term Chehalis Basin Strategy.
  - List of Future Project provide a key input in the OCB Federal Funding strategy development. Projects with local partners already identified are needed to:
    - o identify potential funding sources.
    - o quickly respond to funding opportunities / meet timelines, etc.

Past success: North Shore Levee project => looking to replicate that success

## **Next Steps**

- Develop the list of Future projects.
- 5. Prepare communications plan for annual renewal of Flood Warning System sign-ups:
  - Collaborate and leverage resources of FCZD and OCB (Pyramid Communications).
  - Staff coordinate with Community Outreach & Education Committee on plan development and review.
  - Goal: 3,000 sign-ups
- 6. FCZD Presentation at 11/16/2023 Meeting.
