SUBJECT: Local Project Funding Reallocation

Purpose of this memo is to discuss reallocating unspent funds from Grays Harbor County's Wishkah Road Flood Levee project to the County's Lower Satsop Protection Program for Keys Road and related infrastructure protection. A. Background

1. Grays Harbor County Wishkah Road Flood Levee Project:

- Project began in January 2013 with a study of options to protect and keep open Wishkah Road in times of flooding.
- Solution completed in January 2018 was construction of a sheet pile wall (\$4M) between the road and Wishkah River.
- Additional related projects authorized include:
 - a. Adding additional height to the sheet pile walls in order to pursue FEMA certification of levee at a future date.
 - b. Repaving, regrading, and guardrail extension activities to improve future maintenance.
- Flood Authority approved de-obligating \$238K from the project in April 2019 to help resolve a budget/accounting discrepancy facing the Flood Authority's Local Projects Program (between OFM and Ecology budgets).
- Remaining funds available funds (643K) are insufficient to achieve FEMA certification at this time due to the heavy cost of managing rainfall runoff and drainage behind the sheet pile wall (\$1.2M).

2. Grays Harbor County Lower Satsop Protection Program:

- In September 2017, the Flood Authority endorsed Grays Harbor County serving as primary coordinator/convener of Flood Authority supported projects in the Lower Satsop (https://www.ezview.wa.gov/Portals/_1492/images/Staff%2omemo%20--%20%209202017.pdf)
- In that capacity, the County built a shared vision (2018) for Lower Satsop protection, preservation and restoration activities that meet the interests of landowners, agencies, the County, and many others.
- On November 27, 2018 a dramatic river avulsion compelled Lower Satsop parties to immediate action with the Chehalis Basin Board providing critical funding (\$160K) for immediate development of a reach-scale implementation plan and prioritized investment areas (and actions).

- 3. <u>Projects Committee Recommends Moving \$643K from Wishkah Road Flood Levee Project to Lower Satsop Protection Program for Keys Road and Related Infrastructure Protection:</u>

Projects Committee met (7/16/2019) and concurred with a request from Grays Harbor County (7/15/2019) to move unspent Wishkah Road funds to the Lower Satsop on the basis that:

- Dollar-for-dollar, the benefits of funding Lower Satsop infrastructure protection (e.g., Keys Road, Port Well) are expected to accrue faster and to greater benefit than with the Wishkah Road Flood Levee Project.
 - a. ADT (Average Daily Trips) for Keys Road is 731 with 20% being trucks (2018 data).
 - b. ADT at Satsop River Bridge on Monte-Elma Road was 1,869 trips per day with 8% truck traffic.
 - c. Keys Road is essential for Satsop Business Park with Keys Road being preferred truck route.
 - d. If funded protection activities can be programmed and constructed in the 2020 construction season (July/August 2020).
 - e. In contrast, Wishkah Road Flood Levee project is substantially underfunded to meet current FEMA certification cost projections (\$1.2M for drainage control, pumping infrastructure, etc.) and without a schedule for when benefits would be realized.
- Protecting Keys Road is a precursor to removing full WDFW revetment in 2021 (which has high returns for agricultural landowners and habitat interests)
- See Slide #5 showing accelerated erosion toward Keys Road (62 feet in last year!)

C. Next Step Recommendation

Projects Committee recommends the Flood Authority:

- 1. Approve redirecting all remaining available funds (~\$643K) from the Wishkah Road Flood Levee project to the Lower Satsop Protection Program for Keys Road and related infrastructure protection (e.g., Port Well); and
- 2. Direct staff (Scott) to work with RCO, OCB and CBB to implement this action.
