About the Flood Authority

Formation of Chehalis Basin Flood Authority

In response to the devastating 2007 flood, basin interests came together and signed an interlocal agreement to form the Chehalis Basin Flood Authority. The purpose of the Flood Authority is to develop a basin-wide set of solutions to address flooding issues.

Funding and guidance for the Flood Authority is provided for through several pieces of legislation and agreements: [\[provide links to the legislation for items highlighted in yellow\]](#)

In 2008, the Washington State Legislature appropriated funds to help address the impacts of catastrophic flooding. ESHB [3374](#) and [3375](#) included funding for the Flood Authority.

In 2008, the Flood Authority members signed an [interlocal agreement](#) and sent a [letter](#) to the Office of Financial Management (OFM) requesting funding.

Finally, in 2011, the legislature adopted [ESHB 2020](#), the House Capital Budget, with additional funds for the Flood Authority and a list of action items (see Section 30). OFM signed an [updated agreement](#) with the Flood Authority, including a list of required deliverables.

Membership and Operation of the Flood Authority

The Flood Authority currently has 10 members, including representatives from Lewis, Thurston and Grays Harbor Counties, the cities of Chehalis, Centralia, Montesano and Aberdeen, and the towns of Pe Ell, Bucoda, and Oakville. The Confederated Tribes of the Chehalis Reservation were an original member of the Flood Authority, but sent a [letter of resignation](#) in 2011.

The Flood Authority is governed by agreed upon [rules of procedure](#).

Meetings are held monthly on the third Thursday of the month. A work session is typically held in the morning from 9 AM- noon, and an afternoon business session held from 1:30-3:30 pm. Meetings are now being rotated to different locations to ensure opportunities for local citizens to engage. Meeting locations will be posted online, and information distributed electronically.
