- Usability Studies: In refinement phase
  - Working on a template for changes;

- Reordering menu structure to match Small Business Guide and include the link to the pdfs;
- Changing contrast colors of the Small Business Guide for ADA compliance;
- A/B testing:
  - Feedback banner to go live tomorrow (July 29, 2016) which will link to a customer survey on the content of the Small Business Guide
  - Working on redirects;
  - Reordering contact pages;
  - Working on a way to add the Loan section to the BusinessHub website;
- Received some feedback from agencies.
  - LNI requests adding injured workers information to the Small Business Guide
    - SBLT Some concerns regarding the length of the guide. Original purpose was to consolidate information for starting and running a business in Washington not provide a Small Business Manual.
    - Agreement: Allow the Small Business Guide to become a comprehensive manual and utilize the Business Road Map as a quick checklist.
    - Action: Scott will contacting Janet, DOR to explore the possibilities of updating Business Road Map it to be more of a quick checklist. Road Map will be integrated with the Small Business Guide.
  - o **Recommendation**: Add language in the Small Business Guide informing customers that the Secretary of State can only accept forms in English (per statute).

## **Seattle Restaurant Success Update**

#### Jennifer Tam, Seattle Restaurant Success

- The Small Business Guide is the most downloaded guide on our website<sup>c</sup>;
- Rose & Kayla, LNI; Kim, BLS; and Edmon, LCB have been very helpful along with the other Small Business Liaisons (the SBLT list included on their FAQ page)
- Almost two years since program started and 7,600 people have visited their website (including 20-25 restaurant owners and mobile food trucks)
- Working with Language Line to provide translation services for owners wanting to expand in Seattle:
  - Spanish, Chinese and English are the top three language requests; researching other languages for translation

### **Patrick Reed, Secretary of State**

Meeting Notes: Small Business Liaison Team

- SB5030: Internal Law biggest impact
- SB 5387: model act law that 27 other states have already adopted and we customized it for our purpose
  - Hub and spoke model all follow the same process for filing unifies the process
     all the files the same way (LLC, Corp, etc.)
  - One registration for all foreign businesses instead of multiple
- Commercial Registered Agents: provides a physical address for businesses for paperwork (PO Box is not allowed) individual or business can provide this service (they are legally responsible for the documents). They are not required to be registered, but makes it easier to make changes as needed
- Designation of Registered Agent: Option to name a position or office for registered agent instead of an individual (huge deal)
- Annual Report and Amended Annual Report: Domestic and Foreign entities now file the same report type
- Lot of changes in the terminology. We are now using the same terminology used by other states.
- Titles and addresses of governors are no longer required, just a list of names
  - Domestic profit corporation requires an address still legal community wants the information
- Changes in the dissolution times from 60 to 120 days (domestic) to correct missed filings; no changes to foreign entities
- o RCW 23.95 HUB law (repeal and replace)
- RCW 25.15 LLC statute lots of changes to liabilities
- Action: Patrick, SOS will provide updates to the Small Business Guide as resources become available - they are not major changes.
