- Elizabeth Wheat Provided BusinessHub history and context:
 - o 1st biennium BusinessHub began launch
 - Currently, has a prototype, which is to take the Small Business Guide and serve it via the data sharing agreement
- ORIA and the BusinessHub are working together to make the transition happen on the content of the Small Business Guide to go into the BusinessHub
- Because of the technical expertise at BusinessHub this could be a location of the tax table that Rose Gundersen described – a tax table (one page cheat for UBI Taxes for Employers) to make it easier for customers to navigate through the tax system.
- The updated information in the Small Business Guide will be used for the BusinessHub.
