      - Coordinating roundtable discussions with stakeholders and appropriate agencies – September – want more feedback from business owners so aiming for 10 business owners and 3-4 agency contacts

# **Introduction to Paid Family and Medical Leave Program**

### Clair Delong, Matt LaPalm and Silvia Lugo with the Employment Security Department

- Matt LaPalm passed out flyers with information on the Paid Family and Medical Leave program
  - What is PAID FAMILY & MEDICAL LEAVE<sup>4</sup>
  - o Washington's Paid Family and Medical Leave Program<sup>5</sup>
    - Premiums will start being held in 2019 and employees can begin using the benefits in 2020
    - Organized like an insurance program (i.e. employees and employers pay) and covers:
      - Employee
      - Family members (spouse, parents, siblings, grandparents, etc.)
      - Children (birth, foster, adoption)
      - Certain military events

Thursday, July 26, 2018

- Employers with less than 50 employees are exempt from paying the premiums, but still required to collect and remit premiums and grants to assist with paying premiums are available to employers with less than 150 employees
- Employers can opt out of program; however, they must provide plans that meet or exceed the state benefits
- 8 hour minimum for family medical leave and no additional proof required once claims process completed
- **Request:** Any help or advice the Small Business Liaison Team members can provide in terms of outreach would be much appreciated.
- Recommendation: Add the information into the Small Business Guide and AGR Small Farm & Direct Marketing Handbook

### Scott Hitchcock with the Office for Regulatory Innovation and Assistance

Each subgroup met twice and worked on the purpose

### Liaison/Regulatory

- Agencies are working on leaning their processes, but not always focused on what the businesses actually need to comply or how to resolve the conflicts
- Rose Gundersen, LNI: See <u>presentation</u><sup>6</sup>
  - Contractor Roadmap is now available; developed by Commerce team that developed the Manufacturing and Restaurant maps
  - Currently Commerce team is working on expanding the Manufacturing roadmap to make it broader and applicable to more than one city or county
  - Recommendations: Best practices may help with some of the funding to redevelop Small Business Roadmap
- Grant Pfeifer, ECY: Spoke about the "One Ecology" program
  - Goal to minimize conflicts or silos within the organization by shifting the culture and work practices from competition to cooperation by:
    - Emphasizing ECY is ONE Department current state shows some programs creating own logos

Thursday, July 26, 2018

- Training mangers to work outside their program's work plan (think outside the box)
- Inspire staff to learn something new and be creative and innovative on implementing the rules / programs; some challenges include:
  - Wastewater treatment, which makes water clean enough for reuse, is conflicting with other programs which do not allow the use of treated water
  - ➤ Environmental contaminants (pcp) standards for one program is 10k times more strict than another
- Broaden the understanding of what ECY does by instituting "field trips" to different programs to diversify and understand each other's roles better

### Relationships

- Creating brand identity for SBLT or better way to describe our team
- Creating advisory team
- Creating a contact repository
- Creating a combined distributed newsletter

#### Outreach

- On a regular basis connect with businesses and help them understand what SBLT offers
- Short Term: Small forums to get the voice of the customers
- Long Term: Agency communication team together to collaborate and have events
