Procedures to Come

- ▶ Withdrawal of Filed Record before Effective Date
- ▶ Adding information to Certificates of Existence and Certificates of Registration
- ▶ Annual report form changes RA mailing address must be in WA
- ▶ Resignation of Registered Agent is FREE
- ▶ Three different Statements of Change
- ▶ Commercial Registered Agent Process
 - ▶ Listing
 - ▶ Changing
 - ▶ Terminating

Procedures to Come

- ▶ Foreign Registration Statement to go online and on new paper form
- ▶ Resolution not needed by board to change name for DBA
- ▶ Foreign Entity Withdrawals for different reasons may have different forms
 - ▶ Leaving
 - ▶ Dissolving in their home jurisdiction
 - ▶ Converting
- ▶ Transfer of Registration of Foreign Entity process

More Procedures to come...

- ▶ New ground for administrative dissolution of domestic entities (period of duration has expired)
- ▶ New grounds for administrative termination of foreign entities' registrations
- ▶ New Service of Process Procedure
- ▶ Foreign registration terminated by SOS 60 days after notice is effective
- ▶ If domestic has no registered agent for 30 days, SOS serves notice, and administratively dissolves if not cured within 60 days.
