#### b. 2023 - 2025 UPWP

Lead Agency to present UPWP and call for projects for the next biennium for Council approval.

Lead Agency updated the 2023-2025 UPWP. The proposed UPWP was reviewed with WSDOT and received cursory approval in May.

Josh Fredrickson reviewed the highlights of the proposed UPWP. It is anticipated that \$244,209 will be allocated to QUADCO. The UPWP budget includes \$201,579 to be available to Regional Transportation Planning which includes GMA Planning.

Call for Projects: Lead Agency will put out a call for projects, working for review of submitted projects at the next Council meeting. Lead Agency developed a proposed timeline and associated documents and will send the call for projects in the next week. It is anticipated that \$155,000 to \$165,000 will be available for agency planning projects, similar to previous years.

Discussion was held regarding the 15% administration allocation, and if it will need to be updated as it has not been updated in 16 years. This percentage will remain the same for this UPWP but may be revisited in the future based on staffing needs.

Action: Adams County made a motion to approve the 2023-2025 UPWP as presented. City of Ellensburg representative seconded the motion. Motion passed unanimously.
