## Overview

At the September 30, 2022 special Board meeting, you will preview and provide preliminary direction on a range of projects and actions being proposed by OCB and its partners for the 2023-25 biennium. You will receive an overview of potential proposed budget requests for several major work elements in the 2023-25 biennium, including a summary of proposed work, anticipated outcomes, effects of not funding or delaying funding for the work, key tasks and assumptions, and preliminary cost estimates. Because our time is limited, there are some budget work elements that will need to wait until the October 6 Board meeting to be discussed in more detail.
