Aquatic Species Restoration Plan

- Phased refinement of ASRP
- Updated timing for providing input on all elements of Phase 1 ASRP
- Added task for providing input on Phase 2 ASRP
- Added task for providing input on Phase 3 ASRP to tie ASRP to Board recommendation on long term strategy
- Added task for providing input on investment in post-implementation monitoring.

Project-level SEPA and NEPA EISs

- Removed tasks related to Board providing input on EISs that do not align with agency agreements
- Updated timing for completion of Draft SEPA EIS
- Timing of Final EISs uncertain

Community Flood Assistance & Resilience / Land Use

- Combined with former "floodproofing, floodplain management and land use management" tasks
- Separated out local flood projects
- Added tasks for affirming CFAR objectives and work plan, input on CMZ analyses & mapping and implementation of initial projects, and approval of a basin-wide CFAR program strategy
- Updated timing for providing input on study design of DNR forestry and hydrology analysis

Local Flood Projects

 Added task for approving process and principles for selection and modification of 2021-2023 local flood project lists

 Added task for deciding on 2021-2023 local project list

Development of Long-Term Strategy Assessment and Investment Plan

- Added task for defining content of and process for development of long-term strategy assessment
- Updated timing for tasks related to public outreach and engagement
- Updated timing for approving comprehensive longterm Strategy and investment plan

Major Milestones

Summer 2020, to inform Board recommendations on long-term Strategy and investment plan:

- Provide input on Phase 3 ASRP
- Incorporate comments on Draft EISs
- Approve basin-wide CFAR program strategy
- Public outreach, engagement, and public meetings for draft long-term strategy assessment
- Develop 2021-2023 budget recommendations

Major Milestones

- In Fall 2020, approve comprehensive Chehalis Basin Strategy including an investment plan, implementation schedule, and quantified measures for evaluating the success of implementation
- Board working with stakeholders to advocate for funding to aggressively pursue full implementation
- In early 2021, begin full-scale implementation of Chehalis Basin Strategy
