
FULL-LEVEL OPTION

Description: Revised Scenario 3 level of action, totaling 550 miles of habitat restoration in priority rivers and streams

Estimated cost: \$610 million to \$1.3 billion

Implementation Period: 30 years






Revised Scenario 3

MID-LEVEL OPTION

Description: Scenario 1 level of action, totaling 230 miles of habitat restoration in priority rivers and streams

Estimated cost: \$300-600 million

Implementation Period: 30 years





2021-2023 ASRP BUDGET

Steering Committee Recommendation: \$33 million

- Consistent with Governor's proposed budget
- Almost level funding for ASRP from 2019-21 biennium
- Recommendation does not differ with program options or 6-year funding strategies






Deep pool creation and enhancement will provide fish cold water to escape summer high temperatures








Wood loading on the Skookumchuck and Newaukum will provide new spawning habitat for Spring Chinook and other salmon species

STEERING COMMITTEE RECOMMENDATIONS TO BOARD

Program Option: Strive for full ASRP implementation over 30-year implementation period. Use 5-year program evaluation to help determine feasible pace of implementation

2021-2023 ASRP Budget: Support for \$33M funding level

6-year Funding Strategy: Slow Ramp-up strategy is best option to scale up program at a feasible and responsible pace in early years of implementation
