Welcome, Introductions

Chair Vickie Raines called the meeting to order at 9:14 a.m. and welcomed the Board, staff, and audience.

Consent Agenda

The Board did not have additions or revisions to the June 2, 2022 meeting agenda.

BOARD DECISION: Agenda approved by consensus.

Approval of May 5, 2022 Meeting Summary

The Board did not have additions or revisions to the May 5, 2022 Meeting Summary.

BOARD DECISION: May 5, 2022 meeting summary approved by consensus.

Aquatic Species Restoration Plan (ASRP)

Emelie McKain (WDFW) provided the Board an update on the ASRP's current and future project portfolio. During Q1 2022, the ASRP Steering Committee made a shift from planning to implementation, creating three Regional Implementation Teams (RITs) and a technical implementation team. These teams have facilitated a new funding process resulting in filling 68% of the allocated \$14.4M project portfolio with \$6.8M remaining that has not been allocated.

The RITs have received 22 total projects for consideration, sending 11 projects to the Technical Review Team to evaluate both policy and technical elements of the projects. With new project development efforts underway it has created capacity for sponsors to create new project opportunities.

Key comments and discussion topics included:

- Board members are interested in understanding land ownership along the Skookumchuck River EAR.
- Board members requested further discussion in the future on how the Steering Committee is identifying, implementing, and prioritizing acquisition or conservation easement opportunities.
- Board members discussed the importance of identifying ASRP projects that provide high levels
 of certainty regarding their long-term effectiveness, such as conservation easements and land
 acquisition.

FOLLOW UP ACTION: WDFW staff will return to a future Board meeting to discuss Early Action Reach project site visits.

Local Actions Non-Dam Alternative (LAND)

Alex Dupey (MIG) provided Board members an overview of the May 16-18 Values Planning workshop, which was convened to identify core values and concepts for the LAND alternative. Nine solution categories were identified during the workshop that MIG and the LAND Steering Group will explore as

potential flood damage reduction actions, and what combinations of actions could provide the largest benefits. To supplement the work at the Values Planning workshop, MIG and the LAND Steering Group is gaining a better sense of local resident perspectives by developing an outreach strategy that includes an interactive map-based survey and a text-based survey.

Key comments and discussion topics included:

- Board members were encouraged by the engagement at the Values Planning workshop and the variety of opinions by people with different expertise.
- Board members noted that several of the solution categories identified at the Values Planning workshop have been thoroughly analyzed in the past and recommended that the LAND Steering Group consider that information when analyzing and developing alternatives.

FOLLOW-UP ACTIONS:

- MIG will return to a future Board meeting with a refined outline of the LAND framework.

2021-23 Budget Status and Spending

CBS 2021-2023 Biennium Fund Status Update

Ken Ghalambor (Ross Strategic) provided the Board with an overview of actual spending against projected spending of 2021-2023 biennium funds for all major work elements. The Board was reminded it has authorized ~\$53M and has a reserve of \$17M. Regarding potential release of unobligated reserve funds:

- The ASRP Steering Committee requested the Board approve the release of the \$8.5M unobligated habitat restoration reserve funds available for ASRP projects. Due to habitat construction windows, ASRP projects face possible delay if some unobligated reserve funds are not released by July '22. Project delays can have impact on project success, landowner partnerships, project sponsor trust, priority acquisitions, and project development efforts.
- The Chehalis Basin Flood Control Zone District (FCZD) requested the Board approve the release
 of \$857K from the unobligated flood damage reduction reserve for actions regarding flood
 retention facility mitigation alignments to avoid direct impacts to sensitive cultural resources,
 minimization to fish species during construction, and the potential for significant reduction in
 construction time, cost, and complexity. This request is in addition to the ~\$1.35M already
 allocated from the flood damage reduction reserve by the OCB Director for actions regarding
 the mitigation alignments.
- Port of Grays Harbor and Chehalis Basin Flood Authority staff provided the Board updates on the Port of Grays Harbor Haul Road erosion project. Port of Grays Harbor continues working on permitting, refining solutions, and finding funding partners to address erosion concerns for the

project. Port of Grays Harbor is exploring permittable, constructible short-term solution(s) for the upcoming flood season while providing some protection for utilities.

At future meetings, Board members will continue to discuss when and how to release reserved funds and begin thinking about '23-25 biennium budget priorities.

Key comments and discussion topics included:

- Board members acknowledged the importance of additional analyzes regarding flood retention facility mitigation alignments to preserve tribal cultural sites.
- Board members are interested in understanding how the mitigation alignment work will affect the timing and content of the SEPA and NEPA FEISs.
- Board members are interested in understanding what the public vs private obligations are for the Haul Road project and what the right-of-way status is within project area.
- Board members are interested in the Port of Grays Harbor returning to future a Board meeting with other identified funding partners to support the Haul Road project.

FOLLOW-UP ACTIONS:

- WDFW and ASRP Steering Committee members will return to a future Board meeting to discuss and request funding needs for ASRP projects.
- FCZD will return to a future Board meeting to discuss and request funding needs for flood retention facility mitigation alignment analyses.
- Port of Grays Harbor will return to a future Board meeting to discuss and request funding needs for final construction and mitigation costs for the Haul Road project.

Community Flood Assistance & Resilience (CFAR) Program

Nat Kale (OCB) reminded Board members of their previous conversation at the April 7th Board meeting, where OCB staff requested guidance from the Board for establishing policies for the CFAR program.

Provisional Policy: Base Flood Elevation (BFE) Standards

Based on the CFAR program's commitment to working cooperatively with local governments, OCB staff's recommendation is to defer to 3 feet above base flood elevation (BFE) standards when considering elevating, floodproofing, or otherwise retrofitting a structure.

Key comments and discussion topics included:

• Board members agreed that 3ft is a reasonable standard for the pilot program.

• Board members are interested in understanding climate change modeling and assumptions related to base flood elevation levels under future conditions.

FOLLOW-UP ACTION: OCB staff will return to a future Board meeting to discuss how base flood elevations could be affected by future climate change projections.

Provisional Policy: Demolish and Rebuild Standard

In response to request for clarification from Board members, OCB staff explained situations where CFAR would contribute funds toward the cost of demolishing a floodprone building and replacing it with a new building constructed to CFAR mitigation standards.

The current CFAR policy assumption for "demolish and rebuild" would be:

- 1. The local permit authority considers the building to be in an unsafe or unsanitary condition that renders it uninhabitable, or
- 2. The cost of a flood mitigation project is worth more than the market value of the building.

Key comments and discussion topics included:

• Board members agreed with the demolish and rebuild CFAR policy assumption.

Chehalis Basin Strategy Assessment

Board Chair Vickie Raines provided the Board an update on the status of the CBS assessment. The solicitation of interest has been drafted with support from Board members, OCB staff, and the Oregon Consensus Center. Jim Kramer introduced Peter Harkema (Oregon Consensus Center), who walked through information included in the draft solicitation and requested feedback from Board members specifically on qualifications that should be included.

The selection process will take place in two phases. The first phase includes selection of a neutral facilitator to conduct an assessment. The second phase, pending a successful assessment process, will be an opportunity for contracting to provide ongoing facilitation. Applicants must submit materials before July 8, 2022.
