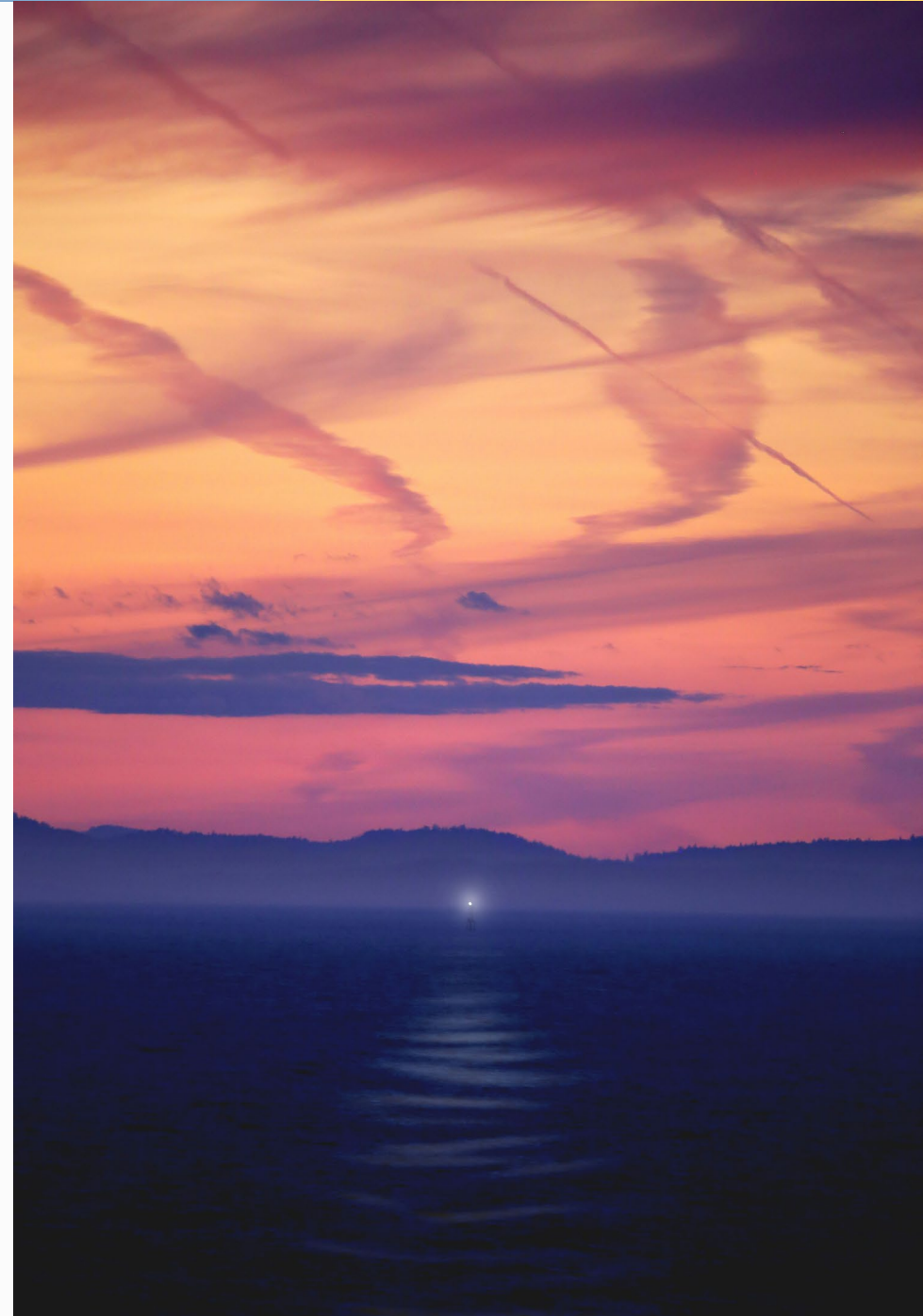

## Phase 3: Sep–Nov 2025

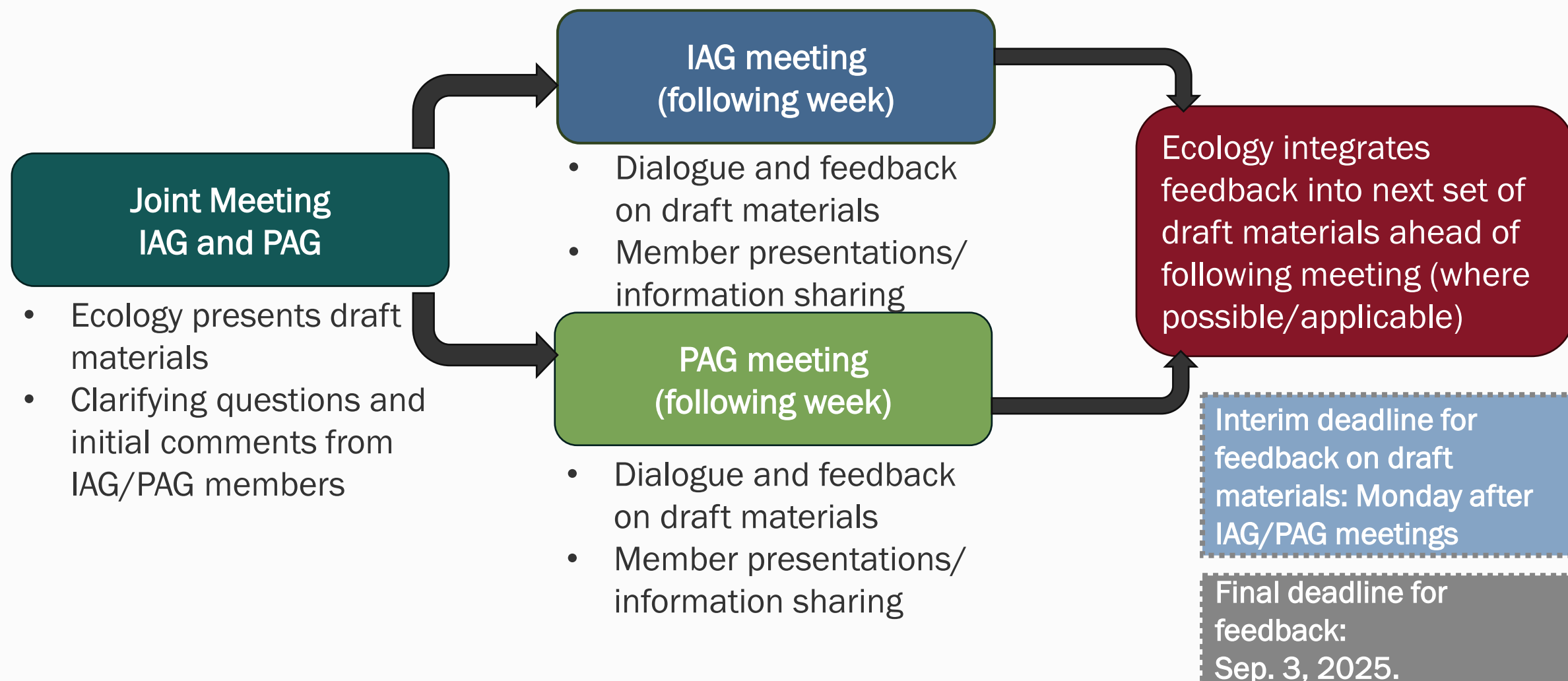
Ecology prepares final report for legislature

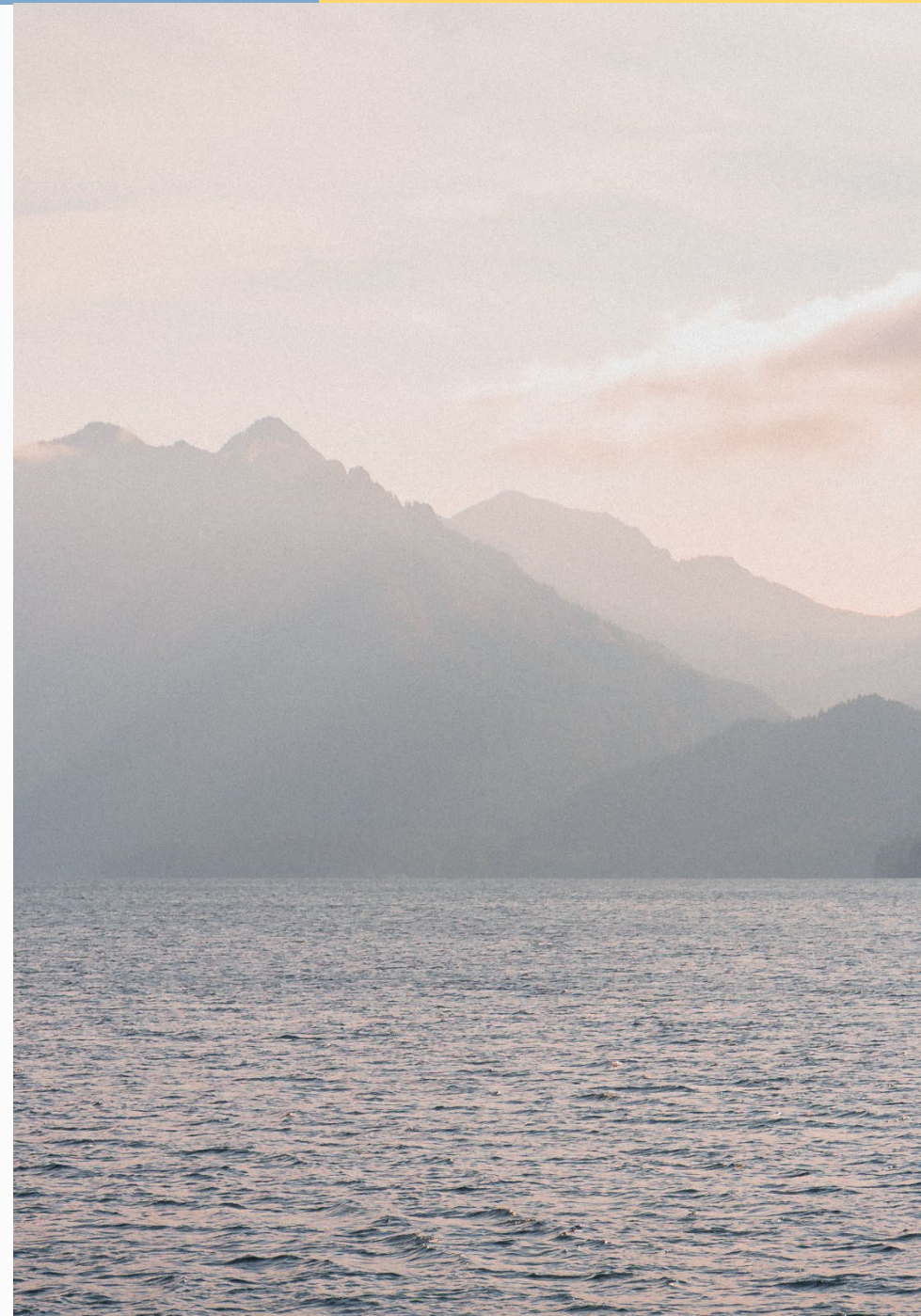
