Overview of potential revisions to be discussed in the course of the working group

The following potential revisions will be shared and then in upcoming meetings working group members will discuss in-depth 2-3 of the proposed topics. Others recommended revisions will be added to the list based on working group member feedback and public input. The potential revisions are not listed in order of priority.

- Update Global Warming Potential values to the Fifth Assessment Report (AR5)
- Expand the list of eligible refrigerants
- Revise 10 year cumulative emissions rates for refrigerants and/or foams
- Revise substitute emissions calculations
- Restrict invalidation of offset credits to non-compliance events that directly impact ODS handling and destruction
- Allow ODS sourced from federal government facilities, excluding strategic stockpiles
- Allow ODS destruction outside the US
- Allow destruction of ODS sourced from Canada
- Revise Point of Origin requirements
