

As part of the <u>WAC 173-446 Offsets Rulemaking</u>, the Department of Ecology (Ecology) is considering revisions and additions to offset protocols adopted in WAC 173-446. Ecology will consider updates to the **Ozone Depleting Substances Protocol**, the **US Forest Protocol**, and consider the adoption of a **Blue Carbon Offset Protocol**. Ecology will invite applications for technical working groups related to each the three protocols within the scope of this rulemaking.

In the near future, Ecology will also invite applicants for an **Environmental Justice Offset Working Group** to inform environmental justice considerations related to any protocol changes that would be considered for the cap-and-invest program. The group is expected to begin meeting in late spring or early summer. Members of this group will not need to have knowledge about offsets or the Climate Commitment Act, and Ecology will instead seek members with lived or professional experience with environmental justice and an interest in compliance offset market projects.

Ozone-Depleting Substances Offset Technical Working Group

Ecology is seeking applications for individuals with expertise in the development, registration, verification, or analysis of compliance or voluntary ozone depleting substances projects to participate in an Ozone Depleting Substances (ODS) Technical Working Group. The purpose of this working group is to help inform Ecology's decisions related to revisions to the adopted California's Air Resources Board (CARB) Compliance Offset Protocol – Ozone Depleting Substances – November 14, 2014. The working group will provide input on a series of potential revisions under consideration sourced from <u>CARB 2021</u> <u>Offset Taskforce Report</u>, voluntary offset market protocols, voluntary offset market protocols, and public comments received during this and previous rulemaking.

The Ozone Depleting Substances Technical Working Group will begin meeting in March. The US Forest Technical Working Group is expected to begin meeting in late May. The Blue Carbon Technical Working Group is expected to begin meeting in the fall. Solicitations from the US Forest and Blue Carbon working groups will be advertised approximately six weeks prior to the start of each group.

Input from technical working group members will help to inform Ecology's rulemaking related to this protocol, in addition to input from the Environmental Justice Offset Working Group, public comments, and programmatic considerations.

Applicant Desired Experience

Applicants for the ODS technical working group should have:

- Expertise in one or more ODS offset protocols in the compliance or voluntary offset market, which may include experience in offset project development, offset project verification, or offset project registration.
- Expertise related to the ODS Projects November 14, 2014 CARB compliance offset protocol is preferred.

Ecology is particularly interested in applications from applicants who have:

- 1) Experience related to relevant offset protocols **and** experience related to environmental justice and/or
- 2) Experience related to relevant offset protocols **and** experience planning, developing, or assessing the feasibility of offset projects on Tribal lands.

Working group member expectations

Working group members are expected to attend virtual meetings facilitated by Ecology and review meeting materials. The working group is expected to meet every three weeks for 3-6 months for 2-3 hours each time. The time and day will be set once the members are selected. Additional meetings may be added as needed. Working group members for the ODS Working Group will participate on a volunteer basis, and will not be compensated by Ecology for their participation.

How to Apply

Applicants should submit a resume and cover letter (1-2 pages) describing their relevant experience and expertise related to ODS offset protocols. The cover letter should include experience with the ODS offset protocol, and the applicant's role in developing or implementing those offset protocols. Please make clear in your cover letter that you are applying for the Ozone Depleting Substances Technical Working Group. Applications must be submitted by individuals, not organizations or interested parties. Applicant may, however, be represented or affiliated with an organization.

Ecology will select working group members based on the individual's experience and expertise related to ODS offset protocols and ODS offset project development, as well as experience related to environmental justice and experience assessing the feasibility of offset projects on Tribal lands.
