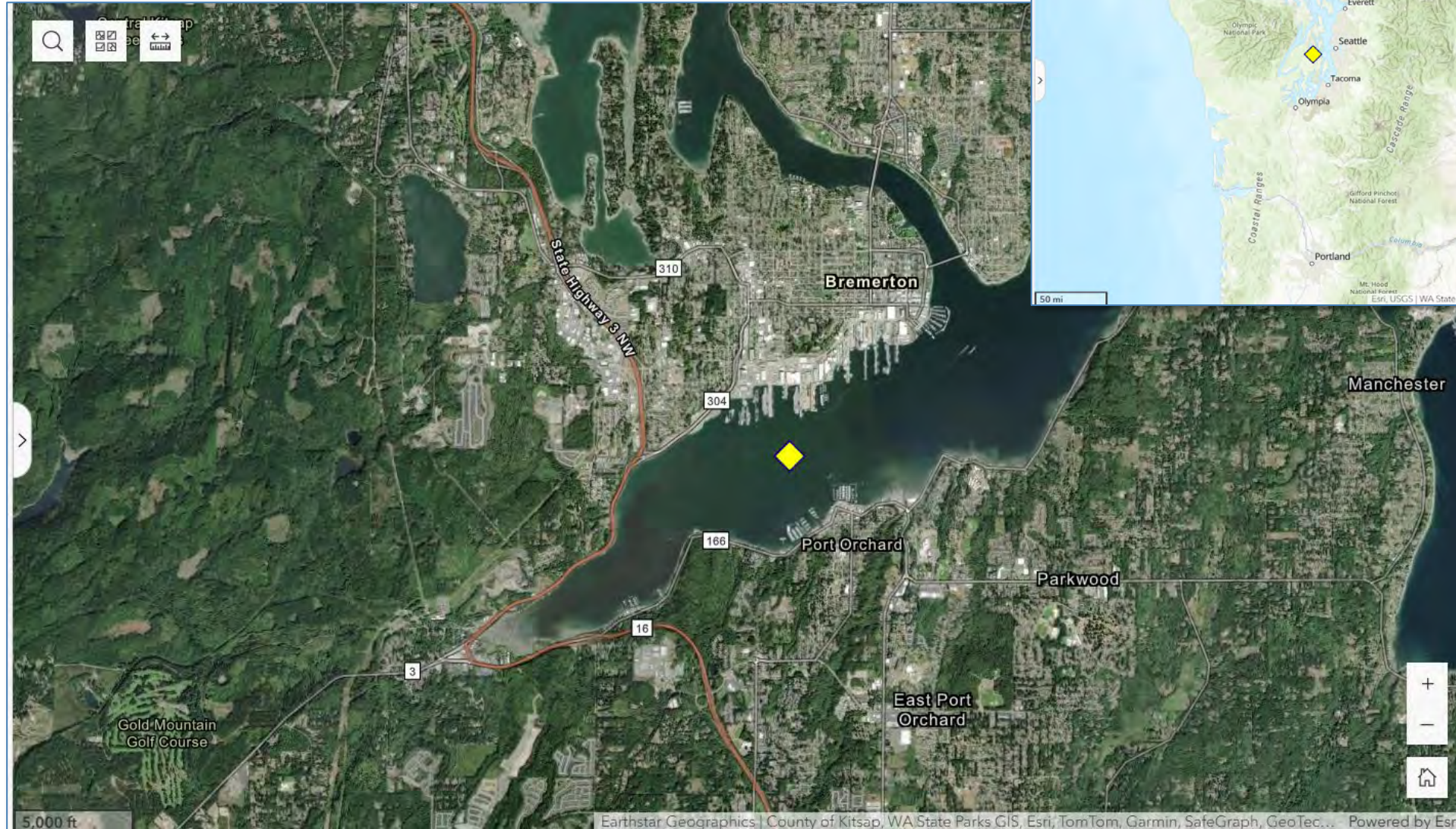

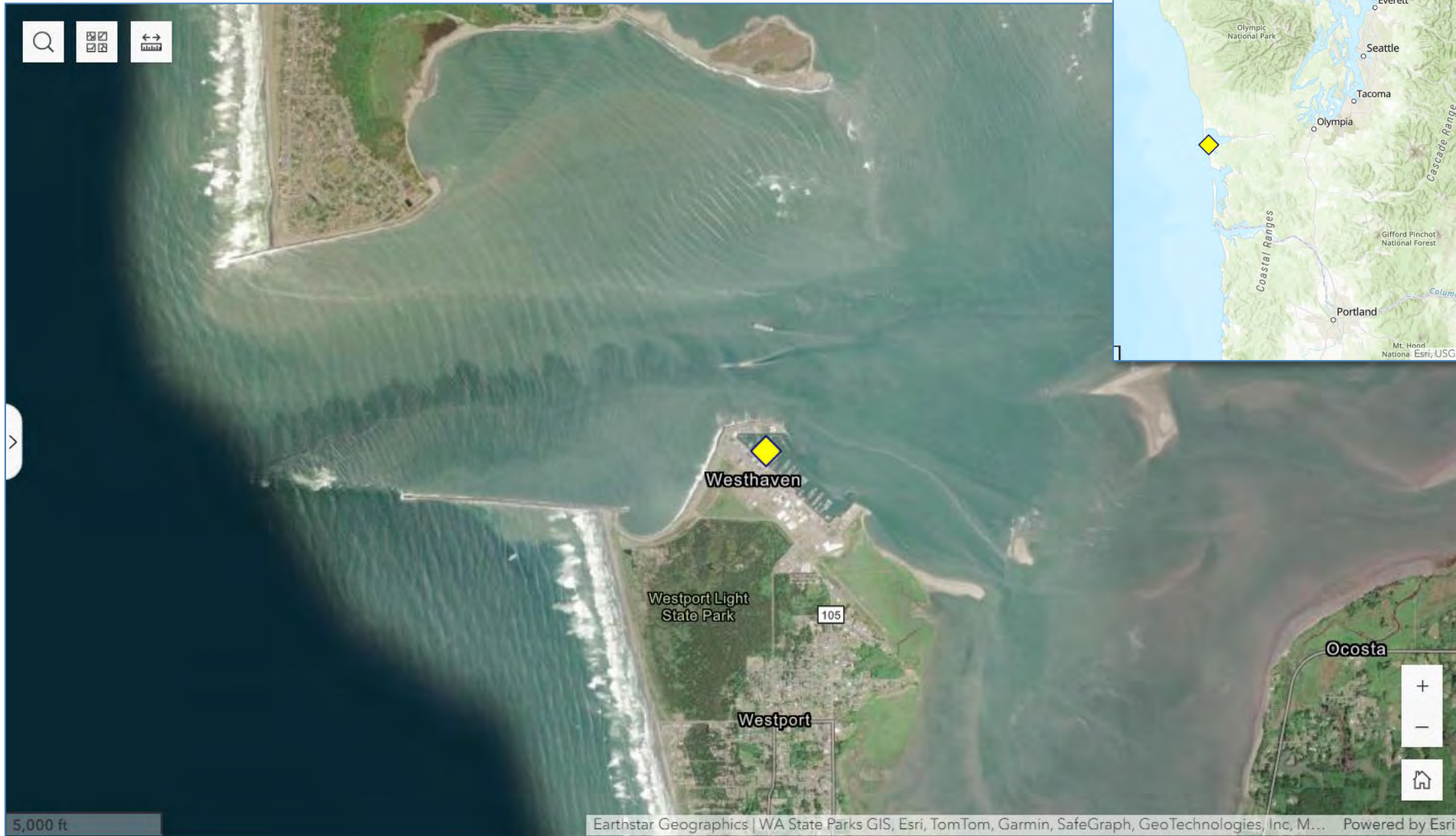

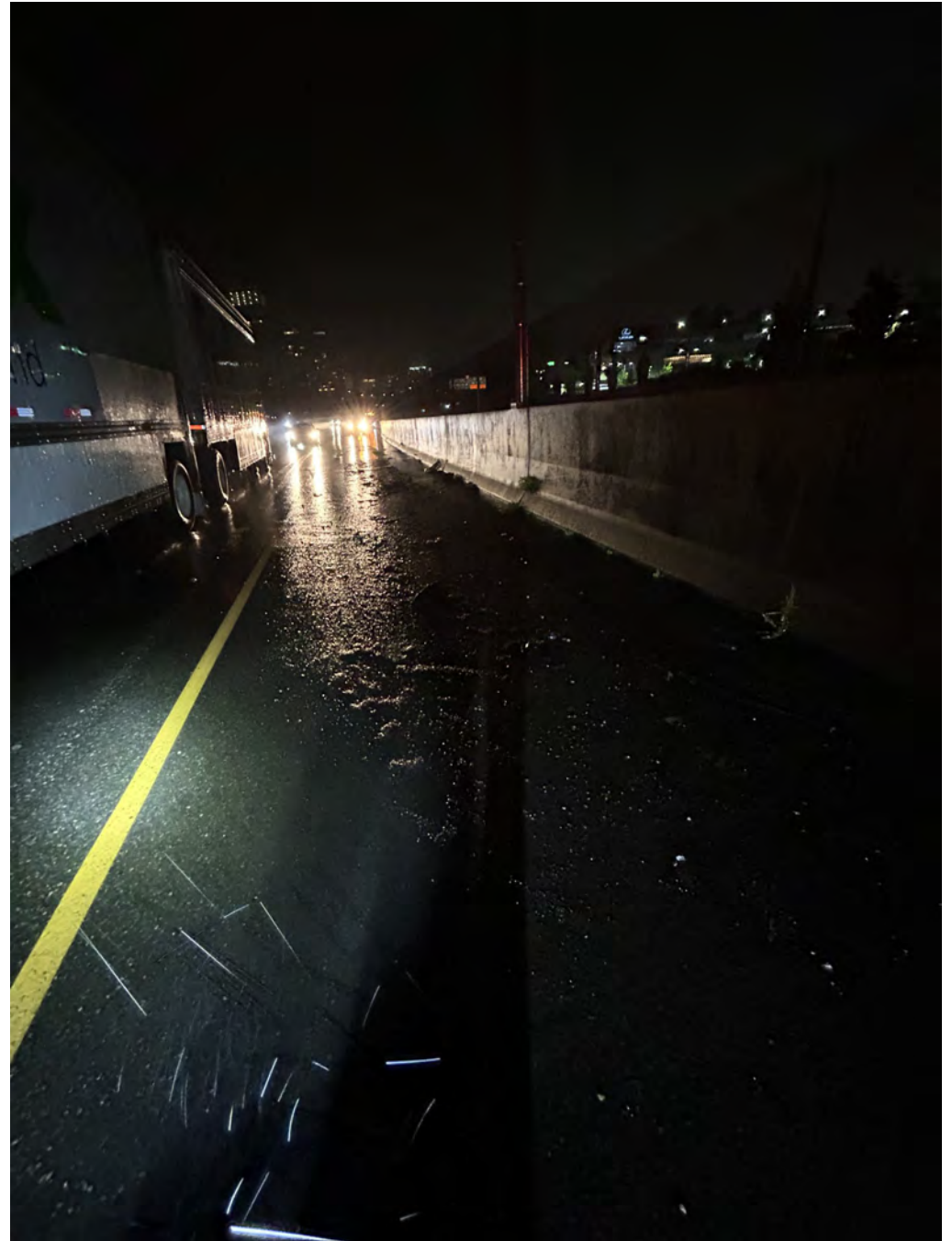
Federal Express semi-truck diesel spill, Bellevue, May 17, 2025
