As per the interagency agreement (IAA) No. C2500087, deliverable 5a is complete. WDFW obtained all the mussels (*Mytilus trossulus*) necessary for deployment to SAM sites from Penn Cove Shellfish aquaculture facility in Coupeville, WA. WDFW staff and volunteers measured and sorted enough mussels to accommodate up to 80 mussels per cage for all 2025-26 Mussel Monitoring sites which include 33 SAM monitoring sites, 3 SAM reference sites, 4 additional SAM back-up sites, and 3 baseline samples. All mussels were measured and selected to fall within the size of 50 – 60 mm which was the median size of the population. A total of 478 bags of mussels were made. The bagged mussels were attached to several lines and hung from Penn Cove Shellfish's rafts where they were left to rest for 14 days before deployment.
