SAM Education & Outreach TAC Meeting # 5 Minutes

We informed the TAC that the team was given a no-cost extension on the project, changing the deadline from Sept 30, 2022 to Feb 28, 2023. All project deliverables will be complete, however, by December 31, 2022.

Task 5: Develop report template

Dr. Navickis-Brasch described changes made to the report template in response to TAC feedback. One piece of additional feedback raised was to add the years to the description of the permit requirement, to avoid potential confusion across permit cycles. The plan moving forward is to now pilot test the template with TAC members, either by using an existing evaluation, one downloaded from the website, or for a potential campaign. Dr. Navickis-Brasch walked through the rubric that members can use to structure their feedback on how the evaluation report template might be further improved.

Task 2: Studies linking stormwater to water quality

The annotated bibliography (Task 2.5) was revised in response to TAC feedback and submitted as final.

Task 4: Website

The website was revamped and revised over the summer based on feedback from the TAC as well as broader feedback from permittees across Washington. In particular, the search function was edited substantially. Dr. Cook proposed removing the "campaign selection" website functionality and replace it with a downloadable spreadsheet. Attending TAC members were supportive of the change. One suggested also adding clearer instructions on how the tool might be used, and another again suggested changing some of the "high-medium-low" to numerical ratings which could then possibly be used to aggregate into scores. The group discussed the quality of the Chesapeake Behavior Change site, and how continuing support for future rounds of the Puget Sound Behavior Index could enable our WA-focused site to provide similar functionality.

Next steps:

- Please pilot test the Task 5 report template and send a copy of the completed rubric to Dr. Navickis-Brasch by Thursday November 4.
- The team will pull together the Task 6 summary documents (a whitepaper, factsheet, and training manual) and provide those in draft form to the TAC by **November 30**. We will ask for feedback by **December 15**, in time to finalize these by the end of the year.

This is the final TAC Meeting for the project, though we will be in touch by email as we ask for comments on Task 6 and wrap up the project at the end of December.
