

# FUNDING SOURCES ADVANCING SALMON RECOVERY & WATERSHED RESTORATION

- Salmon Recovery Funding Board (SRFB)
- Washington Coast Restoration and Resilience Initiative (WCRRI)
- Brian Abbott Fish Barrier Removal Board (FBRB)
- US Fish and Wildlife Service "Chehalis Program"
- US Fish and Wildlife Service National Fish Passage Program
- Family Forest Fish Passage Program (FFFPP)
- Streamflow Restoration Ecology
- Water Quality improvement grants Ecology
- Riparian Funding Conservation Commission (2022-2023 only)



### SPECIAL FEATURES OF FUND SOURCES



US Fish and Wildlife
 Service "Chehalis
 Fisheries Restoration
 Program"

- Started in 1990s!
- \$120,000 per year to Chehalis
  Basin
- Federal match to SRFB



### Salmon Recovery Funding Board (SRFB)

- 1999
- Focus on getting most benefit to multiple salmonid species
- Trusted and integrated "people process": thorough technical and local review
- Backbone from which the ASRP built its successes
- \$700,000/year to Chehalis Basin

### Water quality improvement grants

- Ecology
- Non-point pollution reduction, general restoration
- Restoration groups not applying for many of these in recent years

### • US Fish and Wildlife Service "National Fish Passage Program"


- More funding for barriers
- Typically \$100,000 per year to basin.
- BIL funding being added to this program

### • Family Forest Fish Passage Program (FFFPP)

- Landowners engaged in small-scale forestry
- Just barriers
- Statewide ~\$5 million biennially



- Washington Coast Restoration and Resilience Initiative (WCRRI)
  - · ~2015
  - Focus on jobs creation/ restoration economy
  - Habitat besides salmon (e.g., prairies)
  - Coast-wide fund source
  - Up to \$5 million for Chehalis





- Brian Abbott Fish Barrier
   Removal Board (FBRB)
  - Focus on culvert
     replacement county,
     city, private
  - Ranking formula similar to that used by Lead Entity
  - Can fund more expensive projects
  - Up to \$4.6 million available for Chehalis in 23-25



#### Streamflow Restoration

- 2018
- Projects that enhance streamflow and provide "net ecological benefit"
- Statewide source ~
   \$740,000 awarded last grant round





# Conservation Commission – Salmon Recovery Program

- New program in 2022-2023
- Incentives for voluntary riparian plantings, etc.
- ~ \$ 550,000 awarded in Chehalis Basin



### TAKE HOME POINTS

- Salmon recovery has been funded by many programs over a long time period
- Sponsors always working to mix and match project ideas to fund sources
- Many new programs in last 10 years
- More funding programs bring administrative challenges
- Increasing diversity of funding sources provides benefits -- but capacity is not there to take advantage of all

- It takes nearly as much time to develop/write/manage a grant for a small project as a big one
- Federal programs are looking for work that is strategic, with multiple benefits, that improves ecosystem resilience at a landscape scale
