### National Estuary Program Stormwater Strategic Initiative Lead (SW SIL) - Chanele Holbrook, Stormwater SIL

### Washington Department of Ecology (Ecology) - Jeff Killelea, Water Quality Program Section Manager and Madison Bristol, 6PPD Stormwater Planner

#### 6PPD Work

- **6PPD publications:** There have been several recent publications about WA's work on 6PPDQ
  - [Western Forester](#) – article will be published soon about 6PPDQ and unamended forest soils

- Ecology is recruiting **new 6PPD BMP effectiveness studies**
  - Ecology has received \$2.9 million from the WA State Legislature to continue 6PPD stormwater BMP effectiveness research
  - This research is different than the SWG Effectiveness Subgroup, though we have shared some funding with SAM projects in the past

- The goal of this research is to inform stormwater manual and permit updates
- There is no application for this funding. To get started, reach out to Madison at [madison.bristol@ecy.wa.gov](mailto:madison.bristol@ecy.wa.gov) to discuss project ideas.

- **Industrial Stormwater General Permit 6PPD monitoring**
  - Transportation and waste management facilities will begin quarterly sampling of 6PPDQ in January 2028
  - Currently not enough lab capacity to analyze these samples, so Ecology is hoping to have more commercial labs in WA apply for and become accredited for 6PPDQ

- **[Municon 2025](#)**
  - There will be several at least 9 sessions at Municon about 6PPDQ!

## Permit Updates

- **Several stormwater permits are under appeal.** This includes:
  - [Municipal Stormwater General Permits](#) – settlement discussions in progress with Puget Soundkeeper et al.
  - [Industrial Stormwater General Permit](#) – 7 appellants (mix of transportation permittees and NGOs) have agreed upon 58 appeal issues; PCHB hearing scheduled for Feb 2026
- **Draft [Construction Stormwater General Permit](#)** - Draft released, public comment period closed on May 9, 2025. Final permit will be issued in December 2025.
- The **draft [WA Department of Transportation Municipal Stormwater Permit](#)** is being developed and is scheduled to be released in September 2025
- The **draft [Sand and Gravel General Permit](#)** is expected to be released in Summer 2025
- **Opportunities to discuss permit implementation:** There are several existing forums permittees can attend to discuss permit implementation, including:
  - Washington Stormwater Center (WSC) hosts or supports several permittee meetings intended to discuss implementation topics. We encourage you to join these existing forums to delve into implementation topics beyond monitoring and assessment.     - ROAD MAP – discusses operation and maintenance
    - STORM – education and outreach forum

- WSC hosts 2 Environmental Justice groups, one for municipal stormwater permittees, and one that is a salon and takes on EJ more broadly
- During permit reissuance, if there is permittee interest, WSC has organized the ad-hoc groups that discuss permit topics and develop recommendations. For the 2029 permit, this would begin next year.
