


Using Zoom


The Zoom menu bar appears at the bottom of the Zoom window once the meeting begins.

5. You will see another popup. Enter your **name and affiliation**. Click “Ok.”






Advisory Panel Charter

--Purpose and Outcomes



Background

Must reduce transportation carbon intensity 20% below 2017 levels by 2038



Background

The Washington legislature directs the Department of Ecology to:

“establish and periodically consult a stakeholder advisory panel, including representatives of forestland and agricultural landowners, for purposes of soliciting input on how to best incentivize and allot credits for the sequestration of greenhouse gases through activities on agricultural and forestlands.”

Proposed Purpose

This advisory panel is separate from, but runs parallel to, Ecology's rulemaking process.

Draft rule proposal: July 2022

Anticipated rule adoption:
December 2022



The Advisory Panel provides recommendations and advice to Ecology, which Ecology uses to inform its rulemaking, policy, program, and implementation decisions.

Proposed Purpose

The panel will offer individual and collective inputs and insights to inform the Clean Fuel Standard, including recommendations for:



Quantifying the carbon sequestration impact of current agricultural and forestry production and conservation practices and estimating the potential due to future practices



Identifying agricultural and forest land practices that have measurable greenhouse gas (GHG) benefits



Identifying and developing standards for optimizing/maximizing carbon sequestration for practices on agricultural and forestlands



Developing mechanisms for quantifying and allocating credits to incentivize carbon sequestration on agricultural and forestlands.

Proposed Purpose

Focus on transportation fuels

- Carbon capture and sequestration activities must be related to the production, distribution, or sale of transportation fuels.

Inform the biennial technological review

- "The department must conduct a biennial review of innovative technologies and pathways that reduce carbon and increase credit generation opportunities and must modify rules or guidance as needed to maintain stable credit markets."


