### Board, Commerce, Ecology updates

**Board members** shared the following updates with links to online resources.

- Kyla Fisher, AMERIPEN: plans to publish a white paper on packaging trends for next decade.
- Allen Langdon, Circular Materials: finalized an agreement with Toronto and in January began collection in Ontario as the largest operator in that system.
- Scott Morgan, Evergreen State College: looking for a sustainable solution to waste electronics in school systems. E-Cycle is not an option for his college.
- Jay Simmons: the economic shift in the paper market is overwhelming with printing papers almost disappearing but packaging still strong.
- Mike Range, WM: WM working on the retrofit of the Woodinville material recovery facility.

- Jon Smieja, GreenBiz: <u>Circularity23</u><sup>4</sup> is coming to Seattle from June 5 to 7 "Accelerating the Circular Economy."
- Heather Trim, ZeroWaste Washington: Provided an update on legislative actions in Washington. Find information on the ZWW website.

#### **Commerce update – Rob Duff:**

- Industrial Symbiosis work continues with a request for proposals soon to be published.
- Providing funds for two contracts one with WSU on textiles from hotels and one with Seattle Good Business Network for the WA Materials Marketplace.
- Commerce is a sponsor of <u>Circularity23</u> conference.
- Recent business development topics: Columbia Pulp (fiber manufacturer) could be restarting, MURA Tech (plastic recycling) in Arlington and Divert (organics) in Longview are in the startup process.

#### **Ecology update – Kara Steward** (presentation slides 10 through 14):

- <u>NextCycle Washington</u><sup>5</sup> continues to move forward under contract with King County Solid Waste Division.
  - The Circular Accelerator <u>pitch showcase</u><sup>6</sup> is scheduled for March 23 at Kane Hall on the UW campus from 10 am to 5 pm. The event is free to attend and has a virtual attendance option.
  - NextCycle Washington <u>Renew Seed Grants</u><sup>7</sup> recipients have been selected and will soon be announced: 41 recipients have until June to complete their grant funded work.
    Commerce is overseeing this work.
- An overall update of the Center's efforts for this biennium (July 2021 to June 2023): Aside from agency staff time, the majority of available funds have focused on NextCycle Washington (83%), other projects (17% on studies, research, sponsorships). Our focus in the coming biennium (July 2023 to June 2025) will be committed to NextCycle Washington and staff-led projects.

#### **Ecology update – Mya Keyzers** (presentation slides 15 through 24):

- Provided a summary of commodity prices in the northwest for plastic, fiber, metal, and glass from the RecyclingMarkets.net data Ecology purchases.
- UW Evans School of Public Policy and Governance is researching data and metrics used in market development efforts across the U.S. That report is due in June with a presentation to the Board at the June 14 board meeting. Let Mya know if you want to be on the draft report review team.
- The Eastern Washington Glass Summit is scheduled for May 3, 2023, in Ecology's Union Gap office. Registration<sup>8</sup> is currently open on EventBrite, in person and remote attendance available, free of charge (lunch included) from 9 am to 4 pm.
- Provided an update about the Center board subcommittee on the prioritization tool. The subcommittee will meet again and bring the 'tool' to the board for review at the June board meeting. Conducted a poll of attendees to suggest project work for Center staff.
