





### 6PPD Leg Report and Action Plan Phase 1 Timeline

- June 2024
  - Ecology staff finalize draft
- June 2024 December 2024
  - Agency management, Government Relations, and Governor's Office review
- December 2024
  - Phase 1 of the Action Plan is published as part of the 6PPD Legislative report



### Recommendations

- Some will be supported by budget package for 25-27 biennium.
- Others earmarked for scoping to determine feasibility and approach.
- We will share any significant changes with the advisory committee.

### **Environmental Justice**

- Develop an environmental justice project plan that meets the requirements of the HEAL Act.
- Establish a statewide 6PPD communications collaborative group.
  - Seek funding to support reporting and risk communication on 6PPD and 6PPD-q in overburdened, underserved community media outlets (i.e. radio, newspaper, social media).



New recommendation: Assess the feasibility of a tire industry fee program to support funding for tire contaminant research.

• Determining best program and path to implementation.

### New recommendation: Tire pile removal program

- Lead agency: Department of Natural Resources
- Justification:
  - Develop a framework for tire pile removal.
  - Establish best management practices to pursue the removal of all artificial tire-based structures on state owned aquatic lands.
- Benefit: Restore the benthic environment back to its natural state and continue to protect valuable subtidal and intertidal marine habitat.



**#4: Support primary research that investigates which species 6PPD and 6PPD-quinone may affect and how these chemicals exert toxicity.** 

- New title
- Combined recommendations for clarity
  - Mode of action of 6PPD and 6PPDquinone on salmonid species.
  - Acute and chronic effects of 6PPD and 6PPDquinone on non-salmonid species.
  - Sub-lethal exposure effects of 6PPD and 6PPD-quinone on aquatic life.



#8: Provide long-term funding to support research and monitoring of toxics in the environment. Formalize a permanent Statewide Toxics Ecosystem Observatory program at Ecology to build upon and compliment existing priority toxics in salmonid waterways research.

- We've made the following changes to this recommendation:
  - New title
- Former title:
  - Establish a Toxics and Salmonids Ecosystem Monitoring Program (TSEMP) that integrates and expands existing priority toxics and salmon monitoring efforts.



### **#16: Evaluate the potential for human health impacts of 6PPD due to consumption of aquatic species, including but not limited to salmonids.**



- We've made the following changes to this recommendation:
  - New title
  - Former title: Analyze edible tissues of aquatic species and other biota, including but not limited to salmonids.

### # 17: Investigate the holistic effects on people's health resulting from salmon decline due to 6PPD and 6PPD-q.



- We've made the following changes to this recommendation:
  - New title
  - Former title: Investigate and report effects on people's health from nonchemical stressors that result from 6PPD and 6PPD-q in the environment.

## **#29:** Provide a toolbox for 6PPD-q informed retrofit planning through regularly updating Ecology's stormwater guidance resources and creating supplementary communications materials.

- We've made the following changes to this recommendation:
  - New title
  - Former title: Develop a toolbox of retrofits that stormwater managers and permittees can use.
  - Reframed so that instead of developing a toolbox, Ecology enhances their existing toolbox – aka the Stormwater Management Manuals and TAPE Guidance.
    - This strategy hopes to prevent duplicative work while also improving resources.

# **#31:** Research the extent to which state programs intended to reduce vehicle miles traveled (VMTs) can reduce the volume of 6PPD and 6PPD-quinone released into highway stormwater.

- We've made the following changes to this recommendation:
  - New title
  - Former title: Research the relative impacts of transportation features on 6PPD for use by transportation planners.
  - Recommendation was made more specific to WA State emissions reduction programs instead of being general research into transportation impacts.



### **#38: Determine potential impacts from the proposed 6PPD-q Aquatics Life Toxics Criteria water quality standard.**

- We've made the following changes to this recommendation:
  - New title
  - Former title: Reduce negative impacts to permittees and help permittees the new proposed 6PPD-q Aquatic Life Toxics Criteria Water Quality Standards
  - The intent of this recommendation is now to anticipate which permittees will feel impacts from the criteria adoption and to forecast future costs.

#### #39: Revise requirements for using the statewide environmental vendor pool for 6PPD-q and contaminants of emerging concern.

- We've made the following changes to this recommendation:
  - New title
  - Former title: Exempt 6PPD-quinone from the statewide environmental consultants vendor pool.




### Phase 1 Parking Lot


