

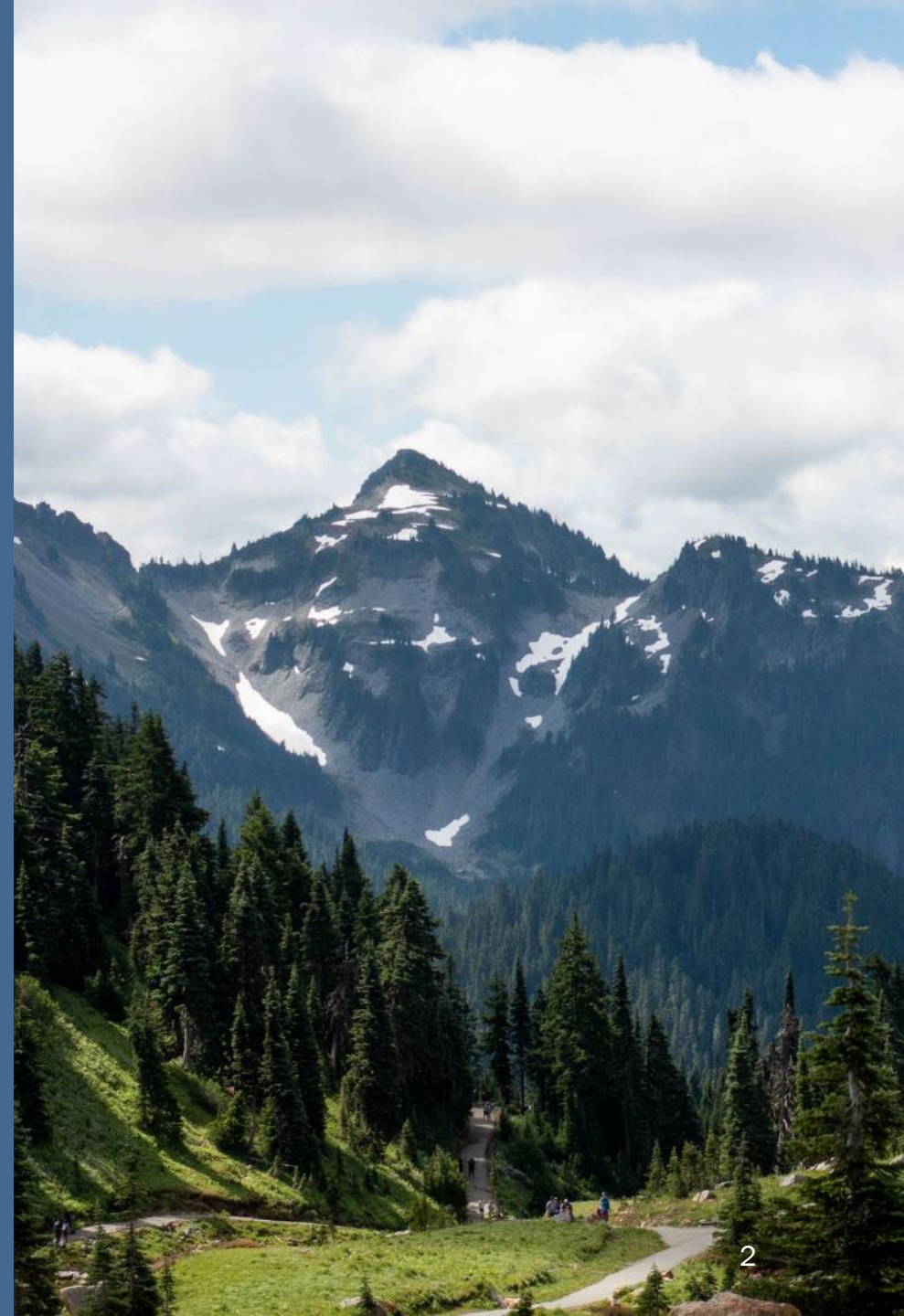

Schedule and Updates





Phase 1 Timeline

- **June 2024**
 - Ecology staff finalize Phase 1 of the Action Plan
- **June 2024 - December 2024**
 - Internal management review of Phase 1
- **December 2024**
 - Phase 1 of the Action Plan is published as part of a Legislative Report

Final Report Due December 2024

- **December 2024**
 - Phase 1 of the Action Plan is published as part of a Legislative report (progress report)

Updates to Phase 1 Recommendations





New recommendation: Assess the feasibility of a tire industry fee program under MTCA to support funding for hazard assessments and filling data gaps on alternatives.

- Determining best program and path to implementation.

New recommendation: Tire pile removal program

- New recommendation with Department of Natural Resources as lead agency.
- Benefits:
 - Develop a framework for Tire Pile Removal and establish Best Management Practices to pursue the removal of all artificial tire-based structures on state owned aquatic lands.
 - Removing these tires is a priority for DNR to restore the benthic environment back to its natural state and continue to protect valuable subtidal and intertidal marine habitat.



#8: Formalize a permanent Statewide Aquatic Ecosystem Toxics Observatory program building upon existing toxics in salmonid waterways research.

- We've made the following changes to this recommendation:
 - New title
 - Added #12: Develop a feasibility assessment for a Toxics Salmonid Ecosystem Health Monitoring Initiative through local source identification pilot studies.



#21: Create incentives and invest in initiatives to identify safer reuse of tire recycling waste and waste tires.

- We've made the following changes to this recommendation:
 - New title
 - Former title: Create incentives and invest in initiatives to identify sustainable chemistry and materials for use in tires and other products that use PPDs.



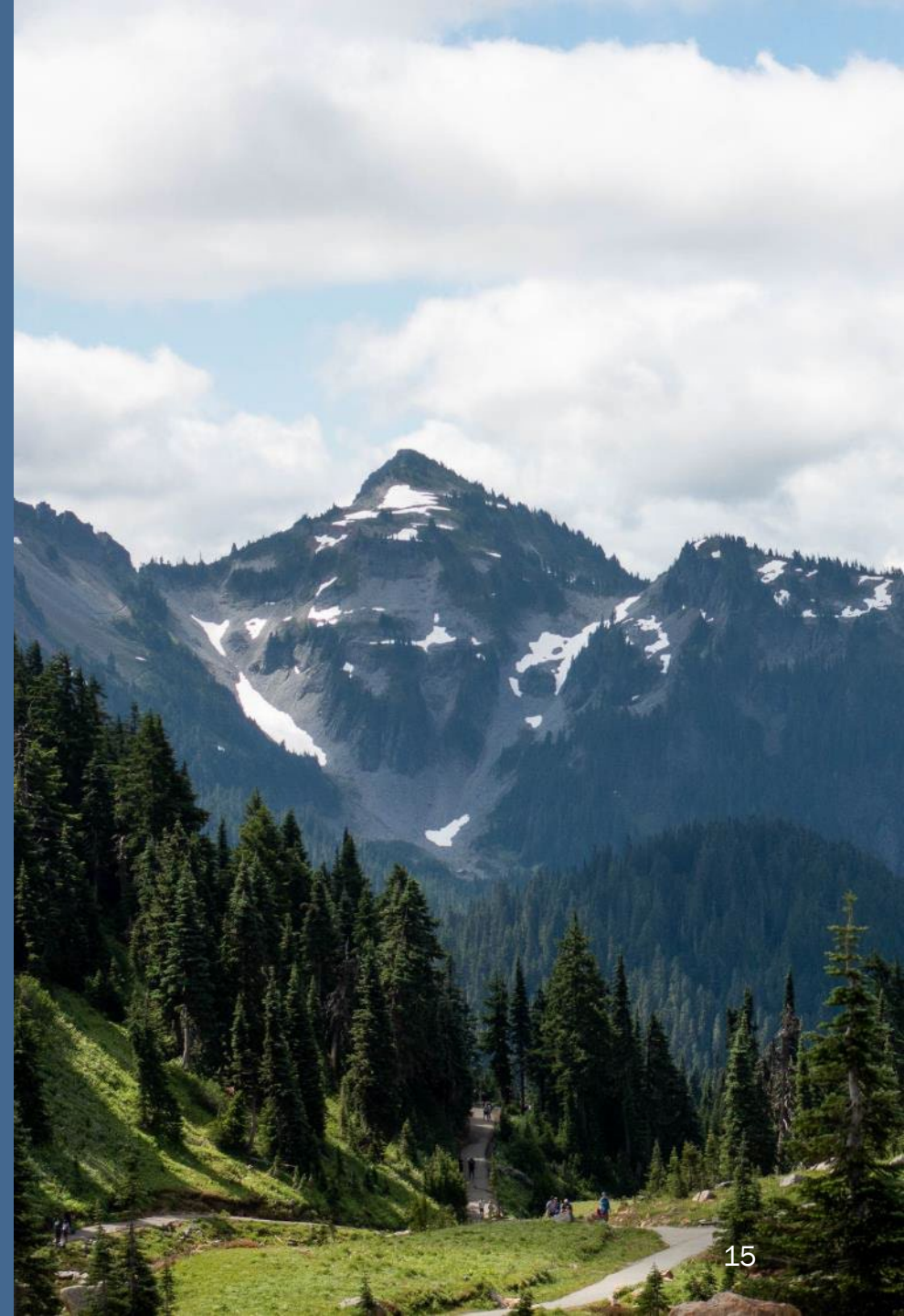
#39: Exempt 6PPD-quinone from the statewide environmental consultants vendor pool.

- Recommendation may not be included in the Legislative report.
 - May fall under the authority of Department of Enterprise.

Implement the low-risk, high-reward stormwater mitigation pilot projects that the Puget Sound Leadership Task Force Stormwater and Transportation Charter Group identified.

- Funding options currently being explored.

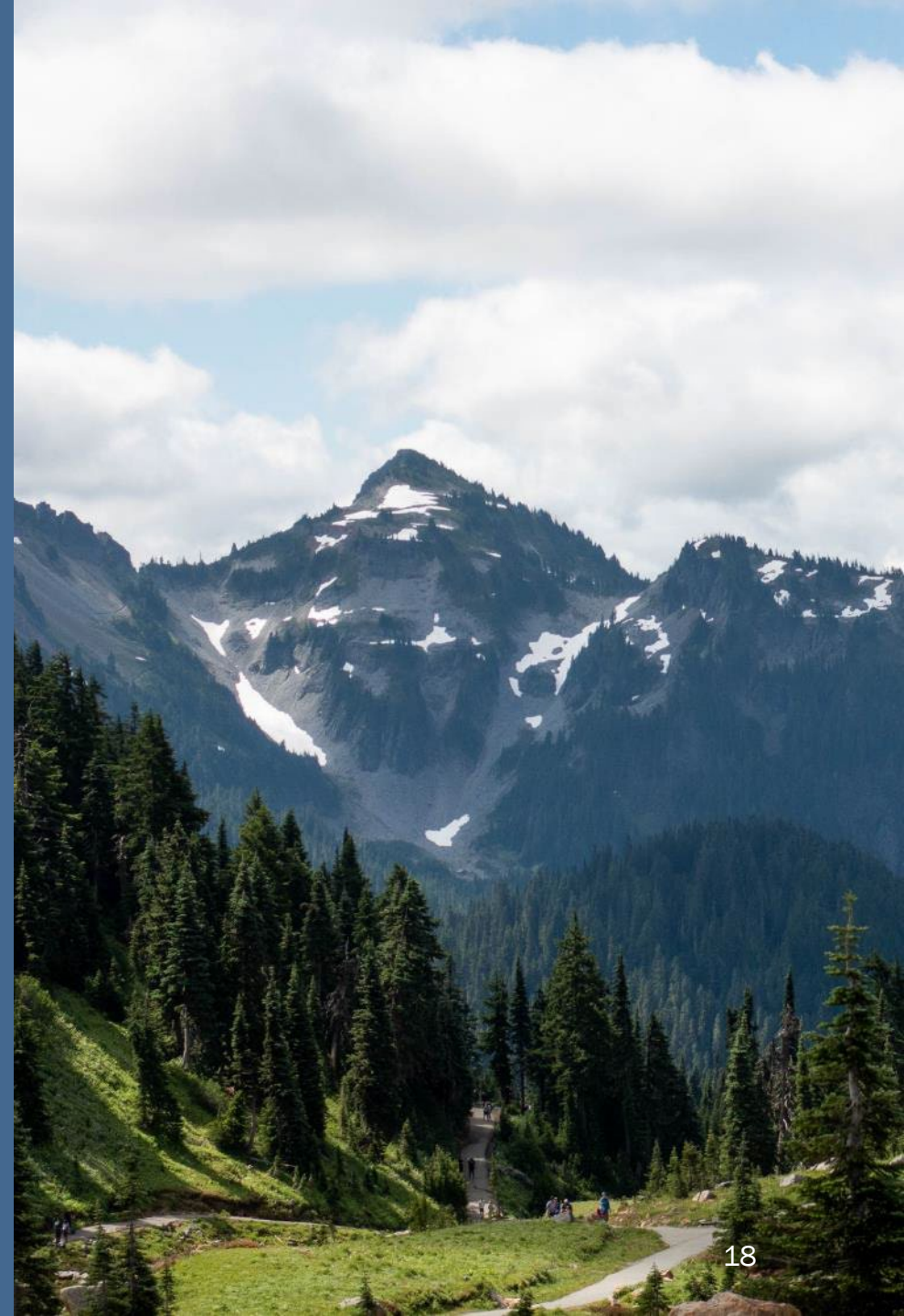
Phase 1 Parking Lot

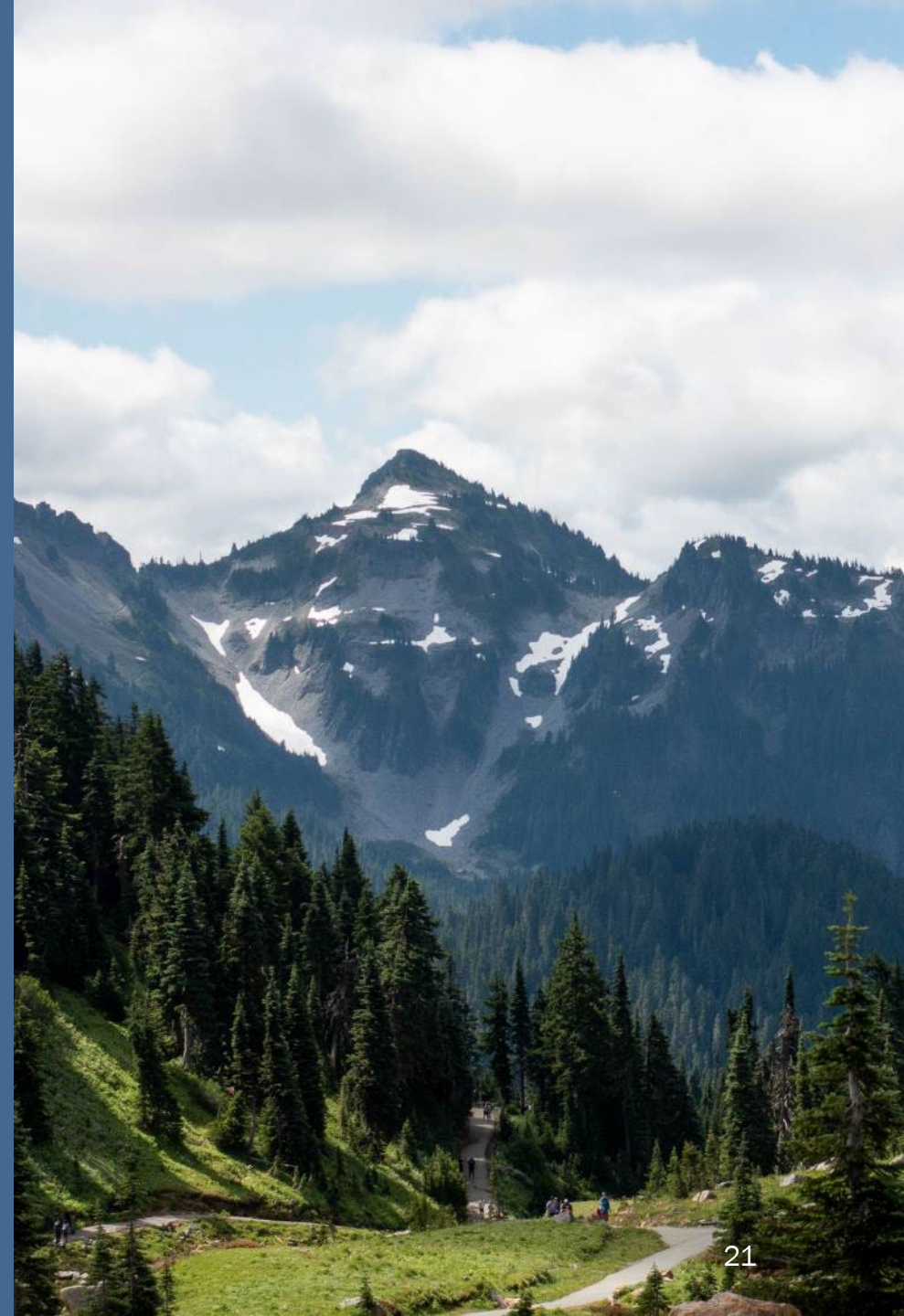

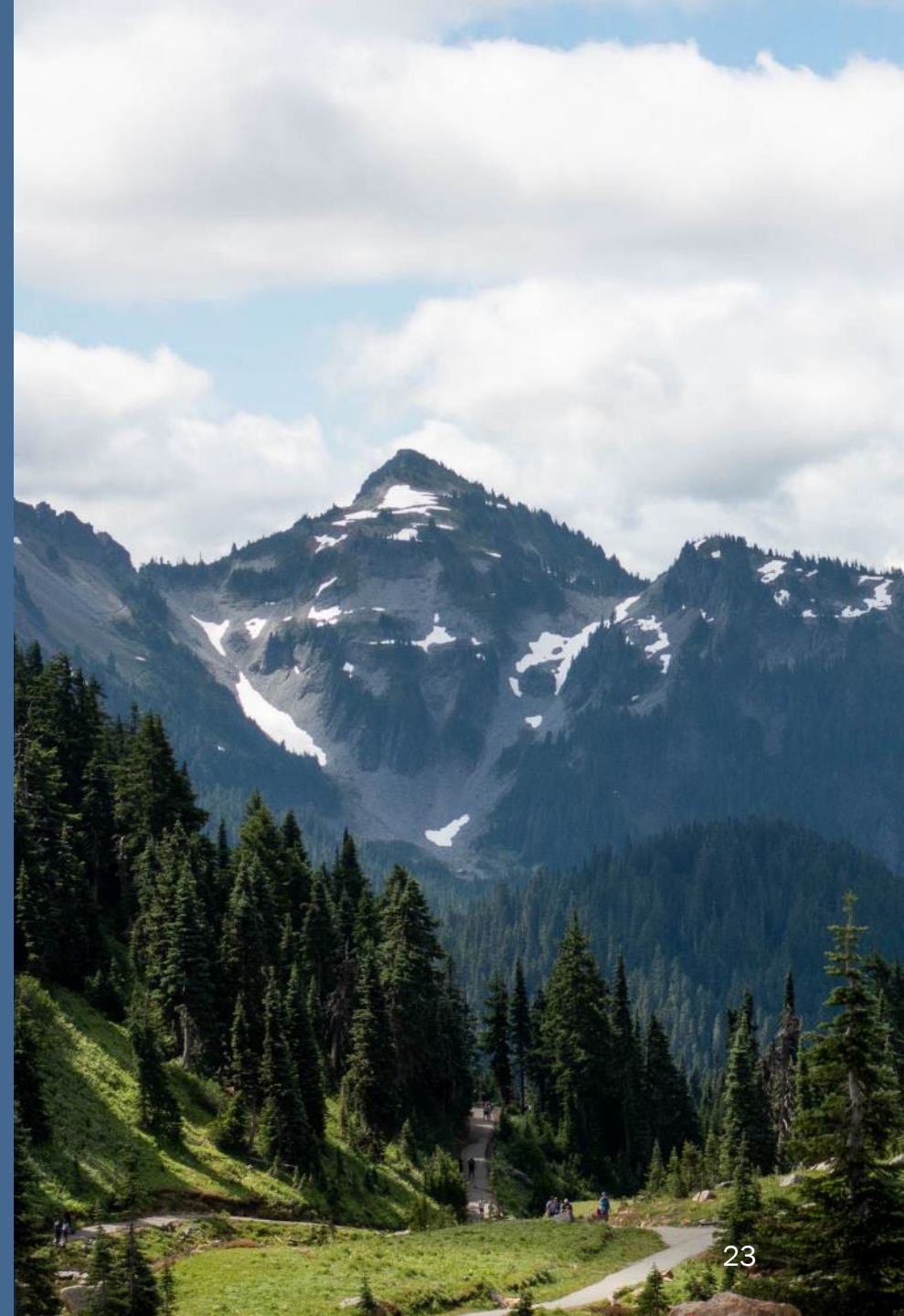
