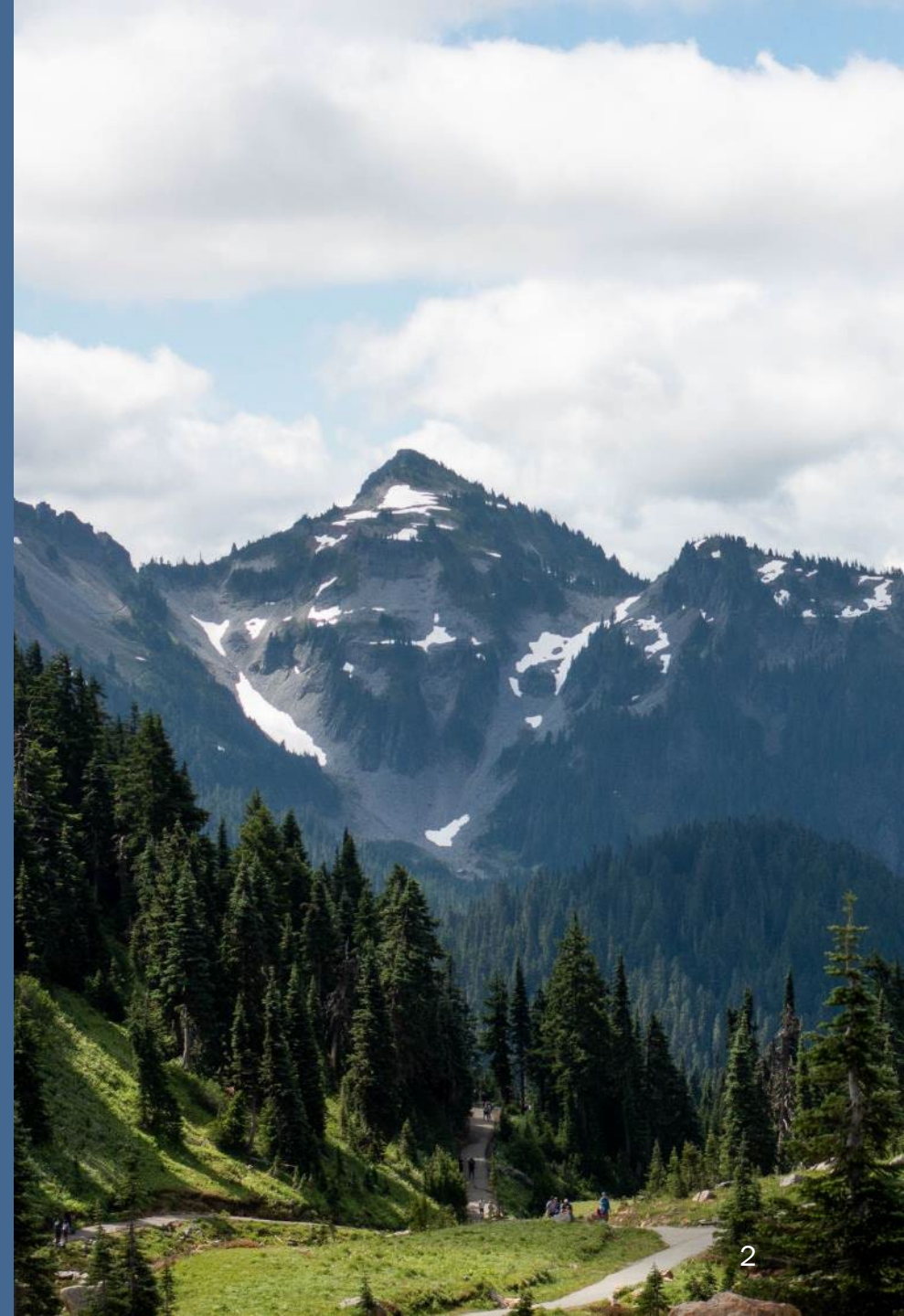

Phase 1 - Objectives

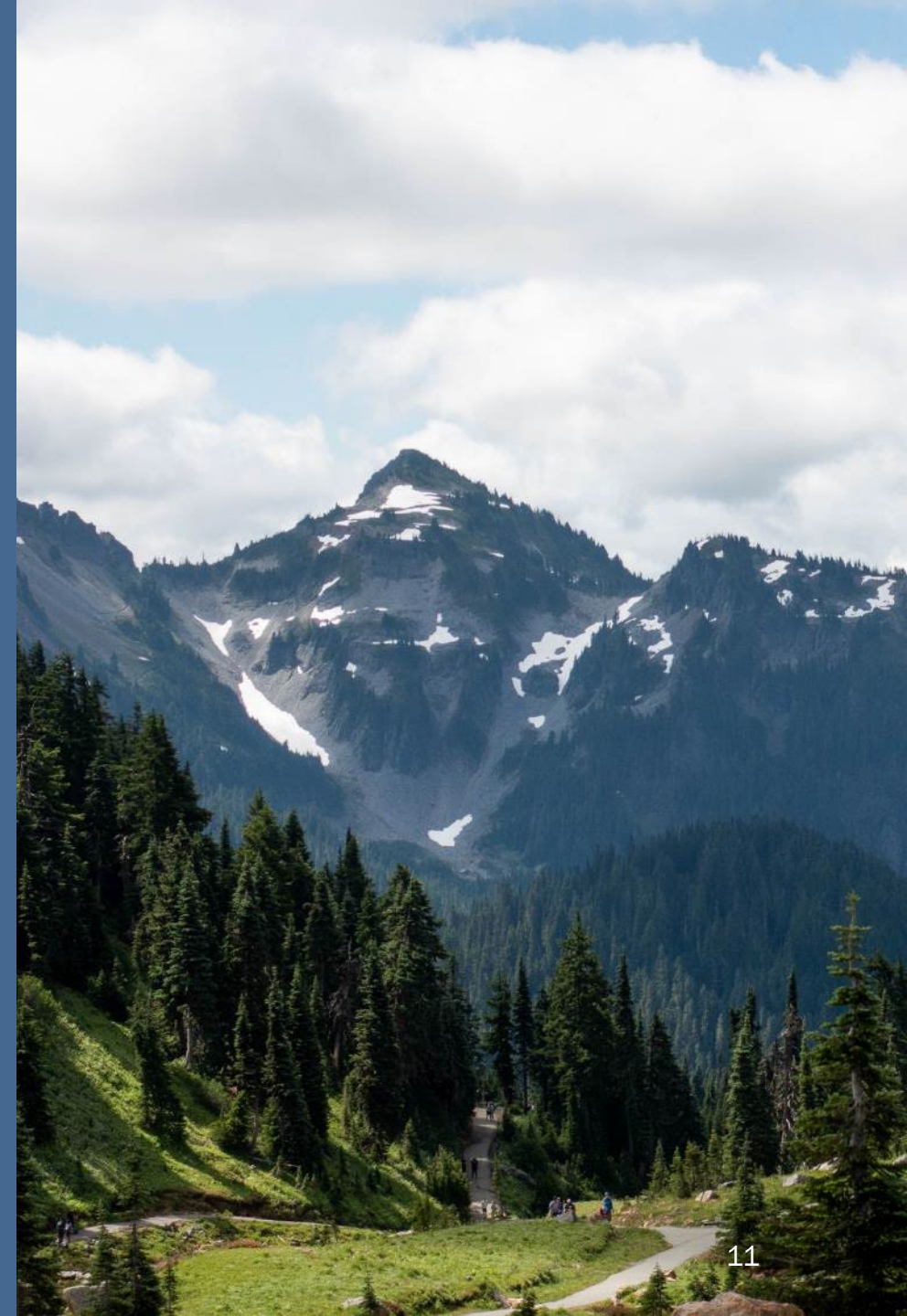
- **EOD March 26:** Ecology archives all working documents.

- **April 17:** Final comments due from advisory committee.
- **April 18 – May 17:** Tribal government review
- **May 21:** Advisory committee wrap up meeting

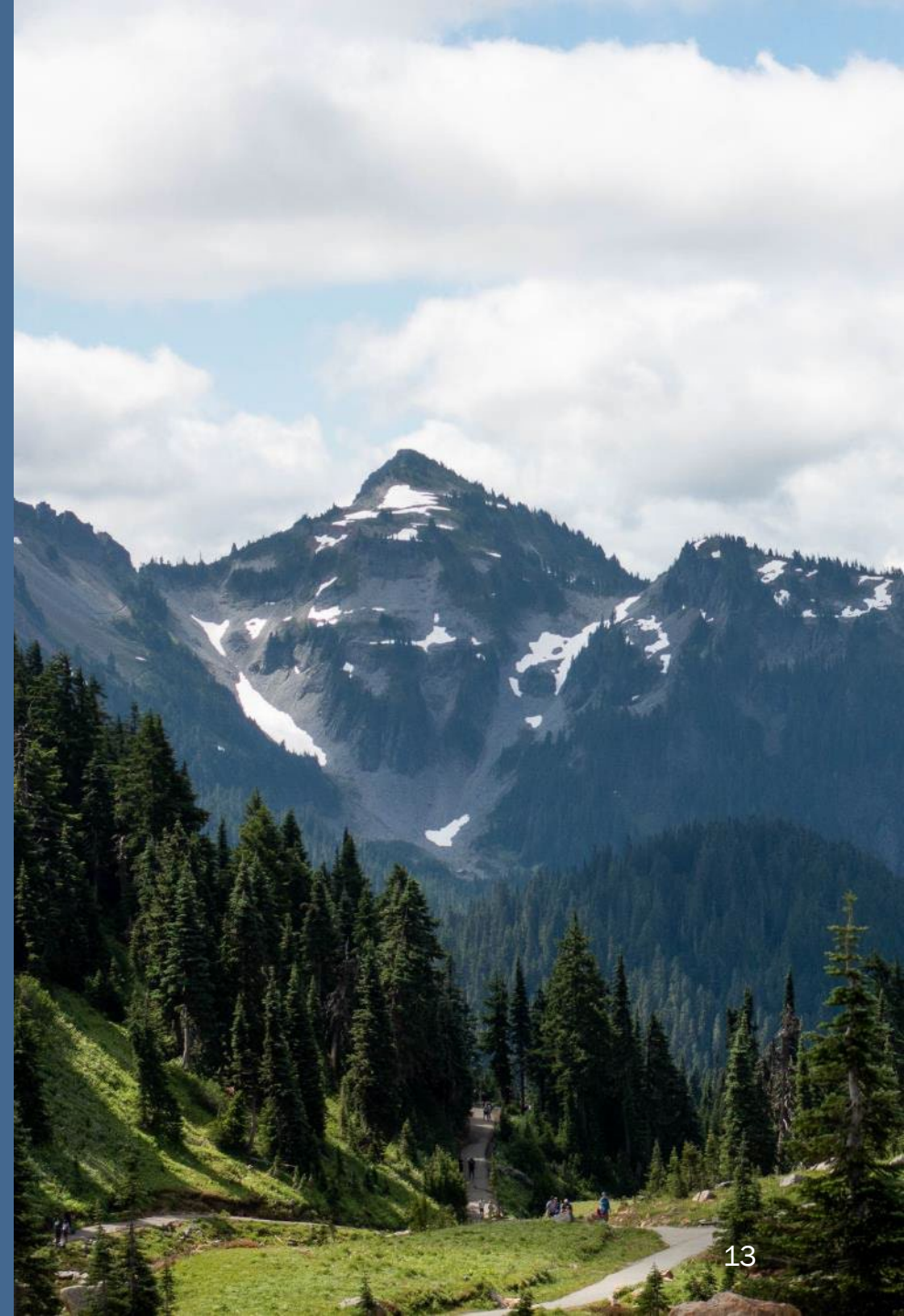
