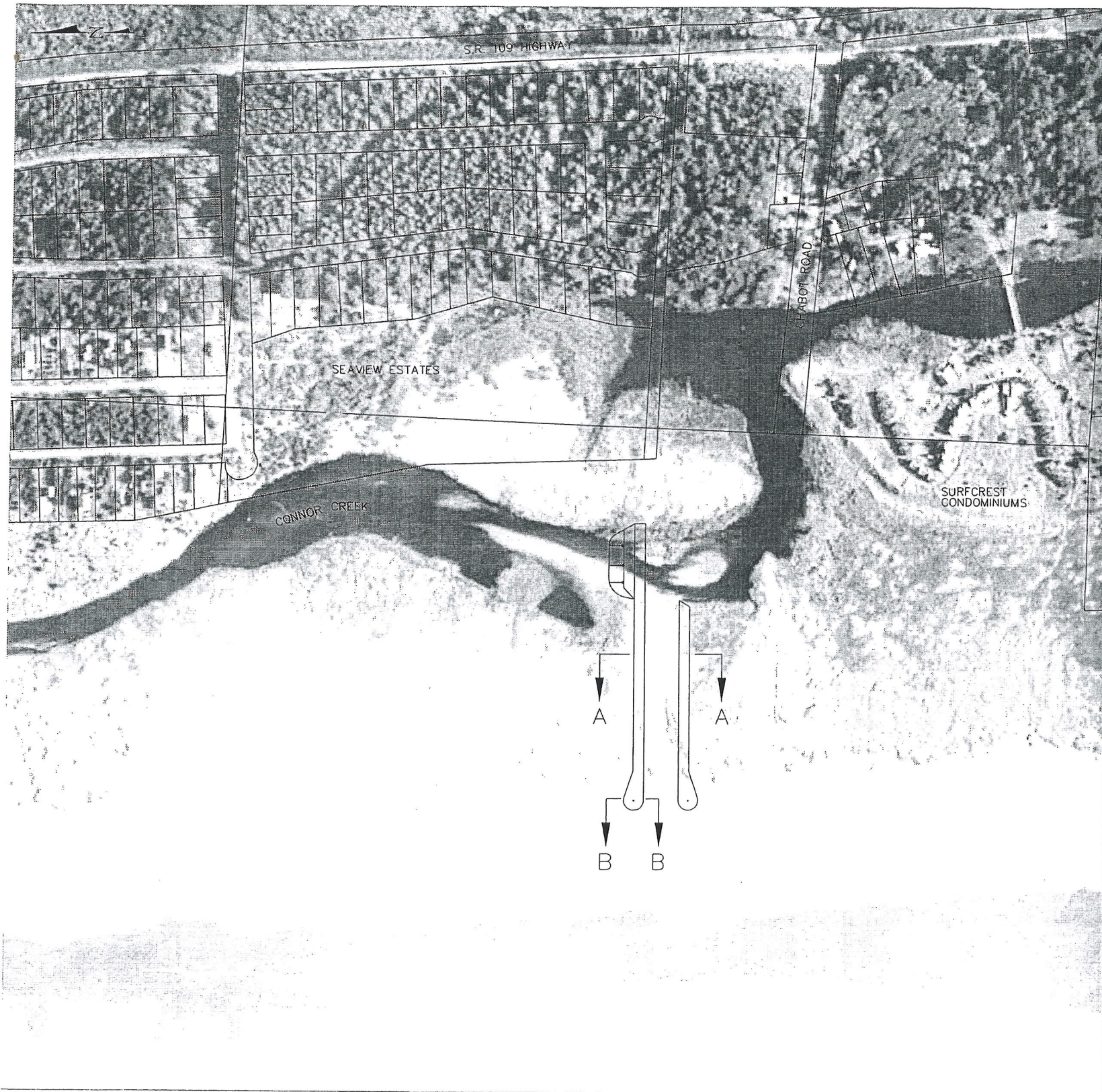
AREA MAP — CONNOR CREEK

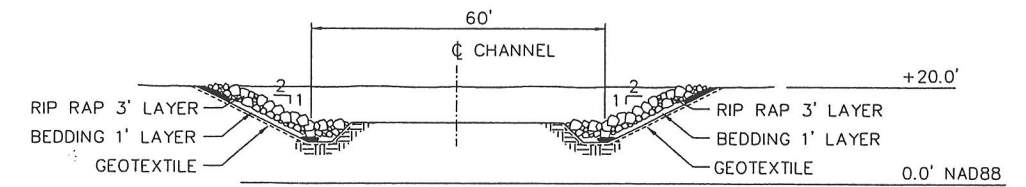

ROCK DIKE CONFINED CHANNEL, TYPICAL



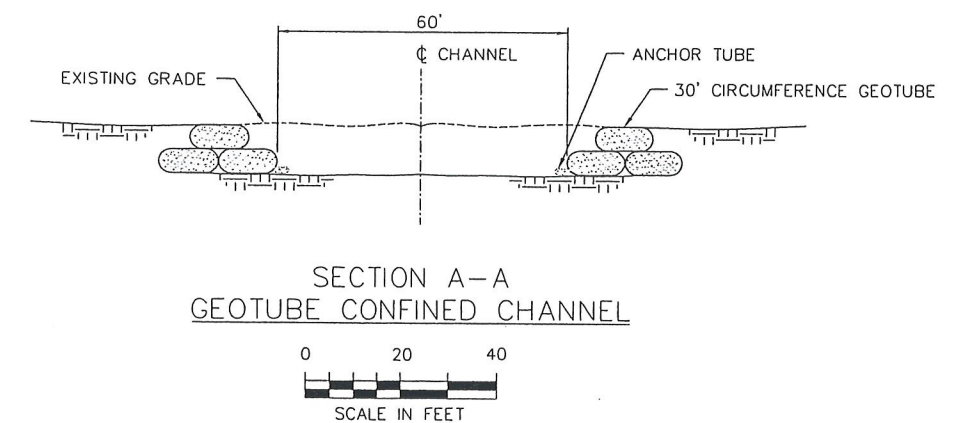

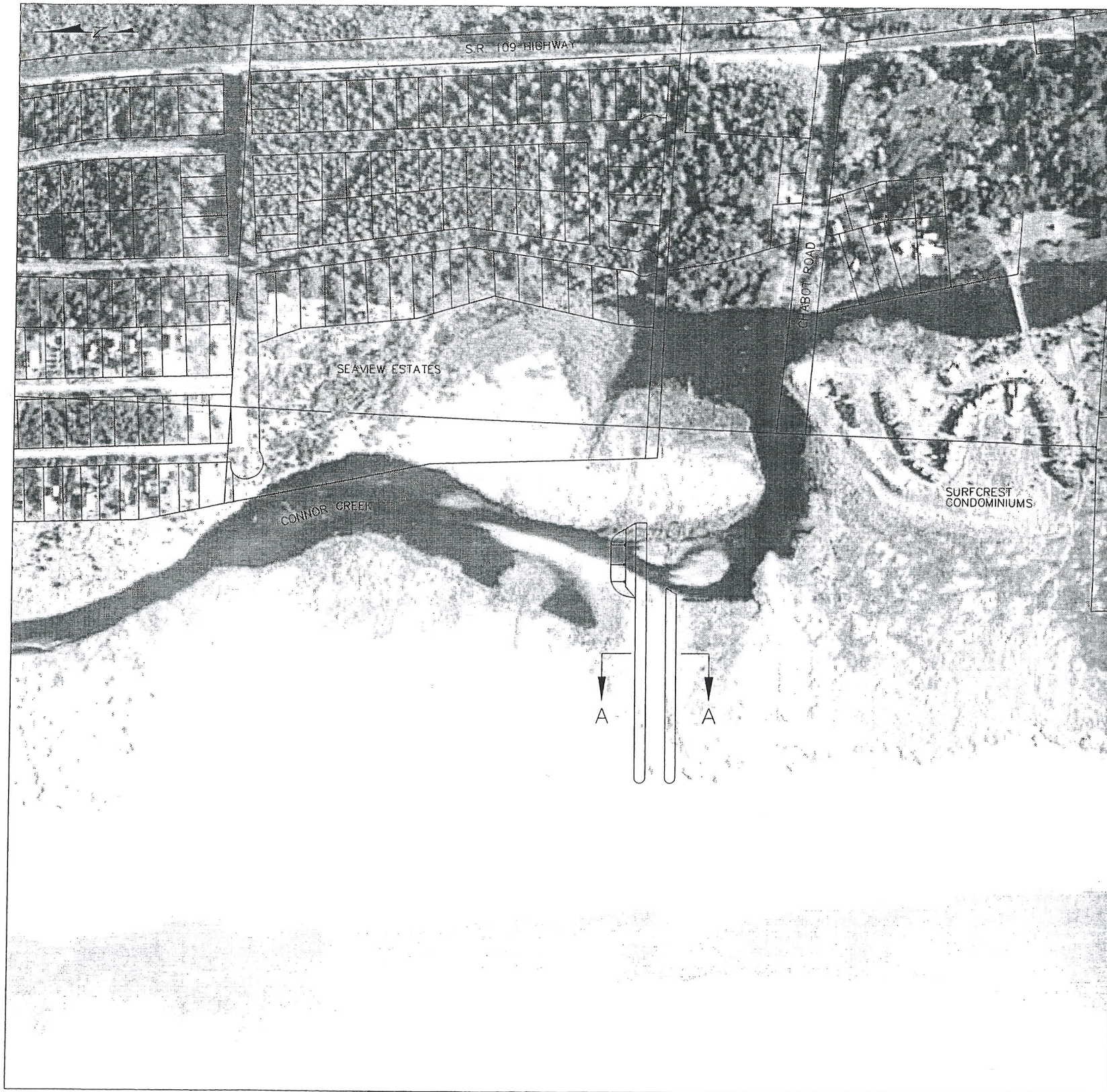


ELEVATION A-A, TYPICAL



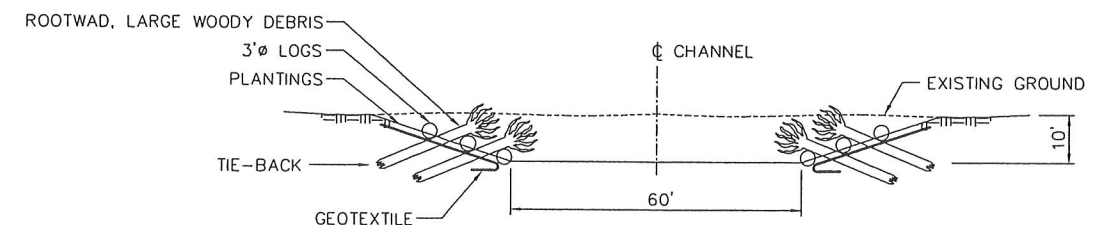

EXCAVATED CHANNEL, TYPICAL



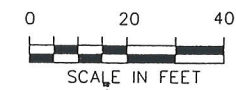

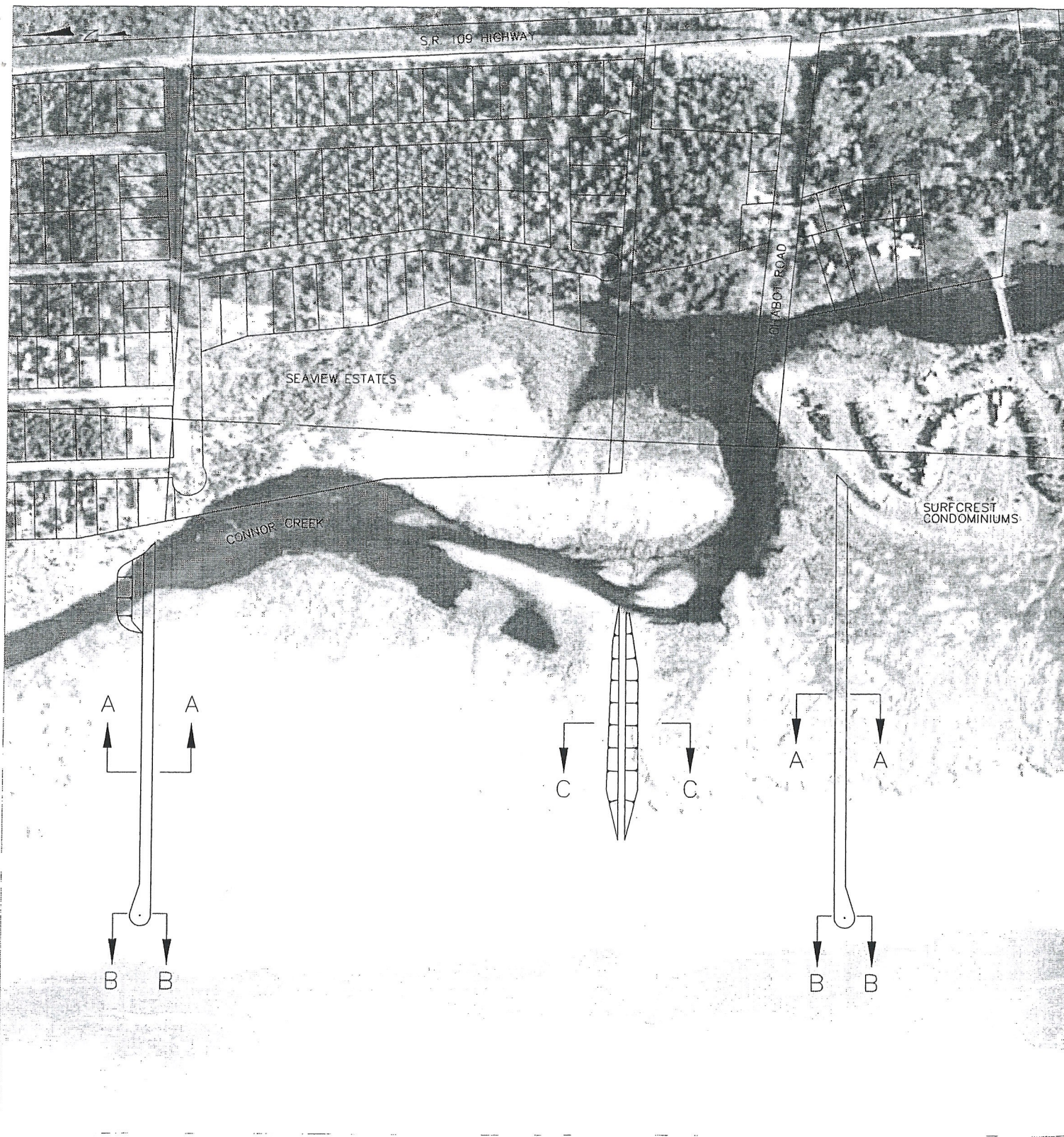

GEOTUBE DIKE, TYPICAL



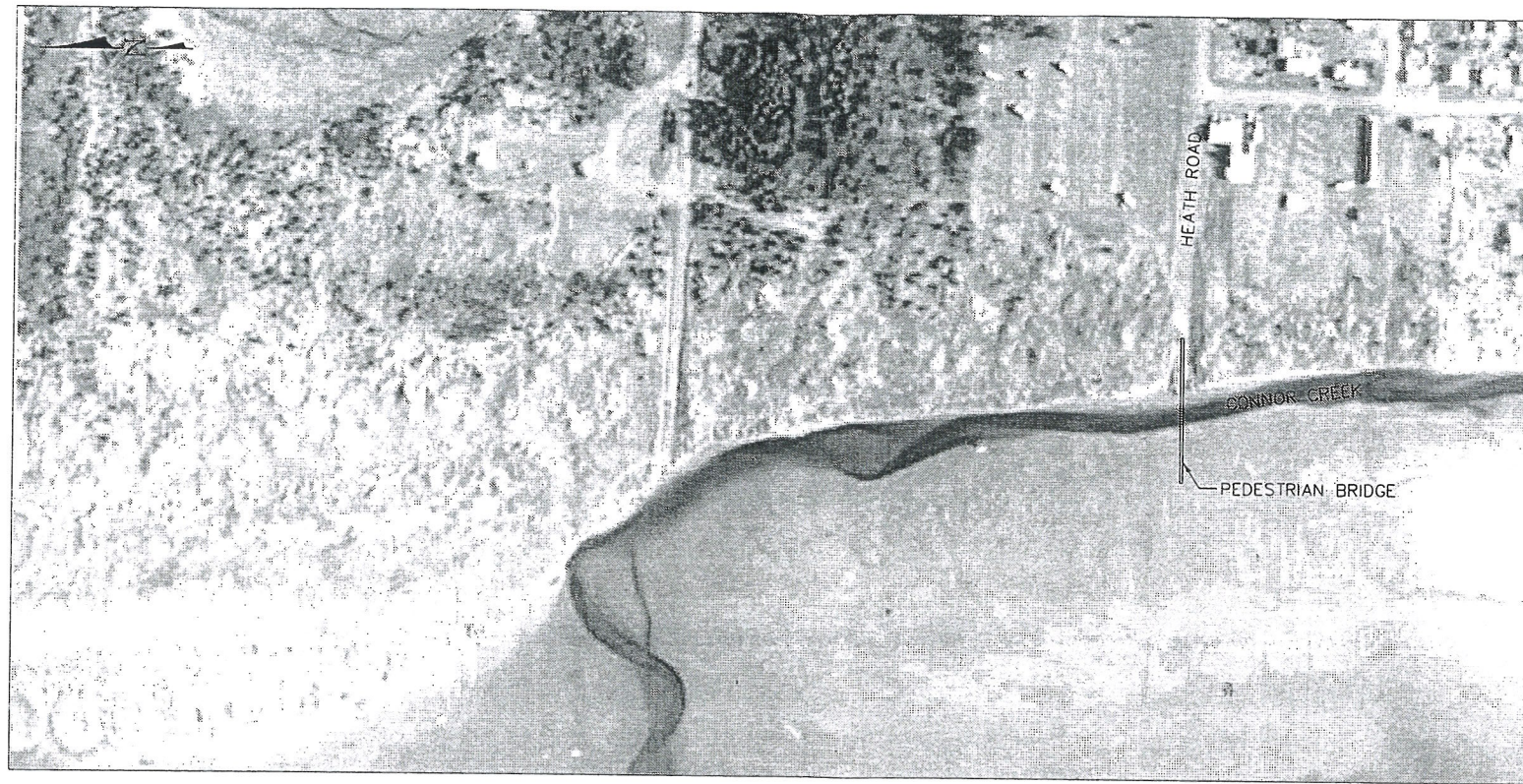

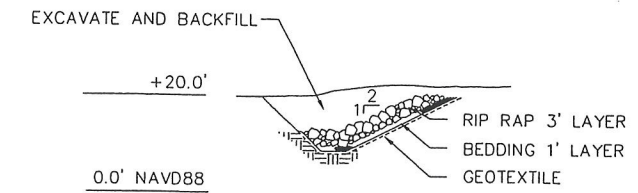
TYPICAL ELEVATION

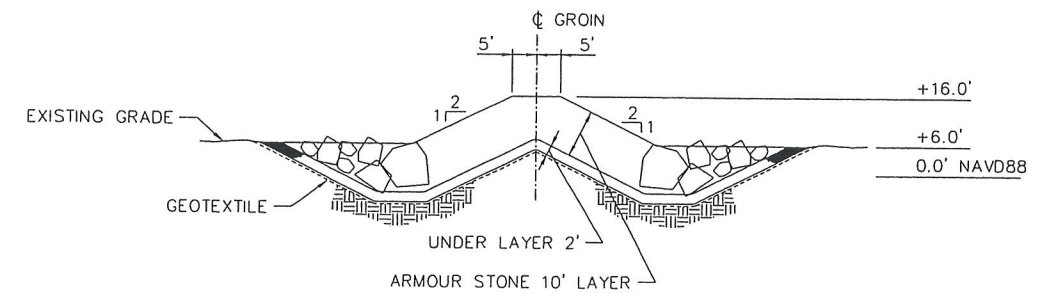
