**Agency:** Washington State Department of Commerce

**Subject of possible rule making:** Recommendations and requirements for housing, urban growth areas, and the rural element in Chapter 365-196 WAC, Procedural Criteria for Adopting Comprehensive Plans and Development Regulations; Commerce may create a new chapter to address recent housing legislation.

**Statutes authorizing the agency to adopt rules on this subject:** RCW 36.70A.190 and E2SHB 1110 – Section 14

**Reasons why rules on this subject may be needed and what they might accomplish:** Updates are necessary to address new legislation on housing, urban growth areas, and rural planning. This includes changes in how local governments plan for affordable housing, increases in residential density, accessory dwelling units, tiny houses, design review, local project review, urban growth area swaps, and infill development in limited areas of more intensive rural development.

**Identify other federal and state agencies that regulate this subject and the process coordinating the rule with these agencies:** Department of Ecology, Housing and Urban Development, Department of Health, Department of Social and Health Services, Department of Veterans Affairs, Department of Archaeology and Historic Preservation, Washington State Department of Transportation, Office of Financial Management, and Department of Labor and Industries. Due to the nature of the legislative changes, Commerce does not anticipate significant coordination issues however, the agency will use the Interagency Working Group to coordinate with state agencies and contact individual agencies directly when appropriate.

feedback from local governments throughout the rulemaking process. Commerce may facilitate focus groups for additional discussion on particular topics with state agencies, local governments and other stakeholders. Commerce will release a preliminary draft of proposed changes and will encourage feedback from tribes, local governments, and other stakeholders. Commerce will consider this feedback before releasing the draft with the proposed rulemaking notice (CR 102). The public will have additional opportunities to comment on draft rules through written comments and/or testimony during the public hearing and comment process.


