Accomplishments and Updates

- Major Milestones
 - → The Major Project Permit (MPP) application was submitted by SSA Marine to Whatcom County. June 6, 2011
 - → The US Army Corps of Engineers (USACE) issued their determination for need of a National Environmental Policy Act (NEPA) environmental impact statement (EIS). June 13, 2011
 - → Whatcom County issued a determination of incomplete MPP application and requirement for a new Shoreline Substantial Development Permit. June 23, 2011
 - → Washington Department of Natural Resources (DNR) issued an Aquatic Lands Right of Entry for sediment monitoring work. June 30, 2011

► MAP Team Communications

- → Department of Ecology (Ecology) and Whatcom County began discussions regarding State Environmental Policy Act (SEPA) co-lead or agency with expertise status.
- → SSA Marine proposed including Settlement Agreement (SA) appellants in MAP Team technical review meetings for documents that are relevant to SA requirements.
- → Conducted MAP Team meetings #2 and #3, and smaller multi-agency meetings for various issues. (Further details in table, below.)
- → Postponed two MAP Team meetings since preliminary documents were not ready for team review and discussion.
- → Created MAP Team sub-committees to allow for smaller, more specialized MAP meetings around specific topics.

► General Public Communications

→ E-mail communications to some MAP Team members initiated on April 27, 2011, were generated by an electronic petition that CommunityWise Bellingham set up for both

Bellingham and Whatcom County residents. Through June, over 600 automated e-mails had been generated.

- → Governor Gregoire and ORA received letters from various groups and individuals about the GPT project and MAP Team. These letters and responses will be posted to a public information tab on the website when that is set up. Letters included the following:
 - City of Bellingham regarding proposal that Ecology take the SEPA lead and that the City be included on the MAP Team.
 - Salish Land Policy Solutions regarding access to and transparency of the MAP Team and GPT MAP website.
 - Physicians associated with WhatcomDocs on health concerns regarding the porposed GPT project.
- → A General Interest tab on the GPT MAP Team website was set up to help address public communications to the MAP Team. An approach to the use and function of this tab is being developed.

▶ MAP Tools Developed

- → Website has excess of 150 registered users.
- → Final standard operating procedures posted to website for MAP Team.
- → Draft matrix of reports, reviewers, and sub-committees developed to show concordance with various regulatory requirements and roles of agencies.
- → Regulatory process diagram and milestones refined to illustrate multi-agency processes and decision points.
- → Tentative schedule updated as key dates are confirmed by responsible agencies.

► Early Project Review Continued

- → Agencies provided comments (April 7) on preliminary documents posted to website on February 28, 2011. Draft comments were finalized and posted for public access.
- → Work plans for marine biota and sediment field work were provided for MAP Team review, and agencies submitted comments.

► Permit Processes Streamlined

- → MAP Team members assisted in quick review and turnaround of permit applications for preliminary field work.
- → Decisions and determinations issued by MAP agencies regarding NEPA, SEPA, county permits, and state permits.
