## **Accomplishments and Updates**

- ► Major Milestones
  - → Agency approvals were issued for marine biology and sediment investigation field work conducted in July and August. June 28 and 30, 2011
  - → Applicant provided final marine biology monitoring plan and response to agency comments on sediment implementation plan. July 14 and August 4, 2011.
  - → Whatcom County (County) and WA Department of Ecology (Ecology) finalized a colead agreement for the State Environmental Policy Act (SEPA) process. July 15, 2011.
  - → Unauthorized wetlands clearing by the applicant resulted in warning and violation notices from the County, Ecology, Washington Department of Natural Resources (WDNR), and US Army Corps of Engineers (USACE). August 3, 2011.

#### ► MAP Team Communications

- → No MAP Team meetings were held this quarter. Planned meetings were cancelled due to lack of preliminary documents from applicant.
- → In September, some of the team attended a tour of Westshore Terminals in Delta, B.C.
- → The National Environmental Policy Act/State Environmental Policy Act (NEPA/SEPA) leads, USACE, County, and Ecology, met regularly to coordinate development of co-lead agreements, including memorandum of understanding (MOU) and request for proposal (RFP) for environmental impact statement (EIS) consultant.
- ► General Public Communications
  - → ORA met with Salish Land Policy Solutions to hear about MAP process concerns.
  - → Letters from Skagit County, Whatcom Docs, and Salish Law were responded to and posted to the website for MAP Team information.

#### ► MAP Tools

- → The website has excess of 185 registered users.
- → The website was reorganized to improve use.
- → The tentative project schedule was replaced with two tools for tracking milestones: completed and pending.
- → The regulatory process diagram, concordance review matrix, report review schedule, and MAP Team subcommittees were updated.
- ► Early Project Review Continued
  - → WDNR and Ecology provided review and comments on sediment implementation plan.
  - → Washington Department of Fish and Wildlife (WDFW) provided input on stream classification.
- ▶ Permit Processes Streamlined (issued in June, but not noted in previous quarter's report)
  - → USACE issued determination regarding Nationwide Permit Coverage for sediment sampling.
  - → WDNR issued permission for sediment sampling.
