Jobs Now Act, ESB 5127 (Section 313, For THE OFFICE OF FINANCIAL MANAGEMENT)

Chehalis River Basin Flood Relief Projects (91000398) The appropriation in this section is subject to the following conditions and limitations:

- (1) Projects funded under this section must be reviewed and approved by both the Chehalis River basin flood authority and the Chehalis tribe prior to the allotment of funds by the office of financial management.
- (2) Up to \$1,875,000 of the appropriation is for repairing and modifying levees and dikes, including but not limited to, the airport levee, levees protecting the Adna and Bucoda areas.
- (3) Up to \$2,075,000 of the appropriation is for modification of the Sickman Ford bridge, and floodplain culverts, to open up the channel, increase conveyance, and allow for flood relief.
- (4) Up to \$50,000 of the appropriation is for installation and calibration of a rain gauge on the Chehalis reservation.
- (5) Up to \$500,000 of the appropriation is for construction of evacuation routes and pads to avoid future livestock losses.
- (6) Up to \$500,000 of the appropriation is for improvements to areas affected by the Satsop river.

Possibilities for Early Warning System O&M

 Divide unfunded costs evenly between each Flood Authority member
 \$67,938/12 = \$5,661/entity

Staffing Options (July 1, 2012 to June 30, 2013)

- Hire new coordinator to perform all roles (facilitation/staff/administrative)
 Considerations:
 - Work load averages about 76 hours/month
 - Cost range for hourly pay likely to be at least \$120-\$175/hour (\$13,300/month at the \$175 rate); flat rate may also be possible
 - May not be possible to find someone able/willing to perform all three roles
 Opportunities:
 - Work with existing contractors
 - Hire someone new (RFQ?)
 - May be possible to do a combination of both (transition/longer term)
- Hire different people/entities to perform various roles

Considerations:

- Potential to do something as transition vs. longer term
- May consider RFQ process for longer term
- May be cost effective to split roles?
- Ruckelshaus Center may be available to help facilitate if roles split

Staffing Options, Cont.

Hire a full time position for coordinator/staff (as a contract employee?)
 with a flat salary/month

Considerations:

- Would need to identify terms of employment (benefits? Location?)
- May be helpful to have someone full time, and in-basin
- May be harder to find someone for limited duration position

Opportunities?

Work with GTH (my firm)

Considerations:

- No obvious choice to do my work
- May be opportunities with GTH-Government Affairs
